10 **MOTION FOR EXTENSION OF TIME FOR FILING OPENING BRIEF**

11 Appellant/Cross-Respondent KIRK HARRISON hereby moves for a 30-day extension
12 of time for the opening brief. This is the first requested extension for the opening brief. The
13 brief is presently due on May 7, 2015. Therefore, appellant requests an extension until June 8,
14 2015.

15 This appeal docket involves an order awarding attorneys fees. Docket number 66157 is
16 a separate appeal involving child custody issues. This court recently granted Respondent/Cross-
17 Appellant VIVIAN HARRISON an extension of time for her combined fast track response on
18 appeal and fast track statement on cross-appeal in number 66157. The combined
19 response/statement is due on May 5, 2015, which is two days before the due date for the brief
20 in the present docket. The proximity of the due dates, including the due date for Kirk Harrison's
21 response to the fast track statement on cross-appeal, will create a burden on Kirk Harrison in
22 preparation of the opening brief in this docket.

23 Additionally, the issues on appeal in this docket are unusual and complex. Kirk Harrison
24 and his counsel are unable to complete the brief within the present deadline.

25 Accordingly, we request a 30-day extension of time for the opening brief, with a new due
26 date of June 8, 2015.
