MOTION TO DISMISS CROSS-APPEAL

Appellant/cross-respondent Kirk Harrison hereby moves to dismiss respondent/cross-appellant Vivian Harrison's cross-appeal.

On September 10, 2014, Vivian filed her docketing statement for the cross-appeal. The docketing statement reveals that the cross-appeal was not timely. Specifically, Vivian's answer to Question 15 reveals:

- 1. Notice of entry of the order on the tolling motion was served on June 16, 2014;
- 2. Kirk filed his notice of appeal on July 7, 2014; and
- 3. Vivian filed her notice of cross-appeal on August 12, 2014.

Pursuant to NRAP 4(a)(2), notice of a cross-appeal must be filed within 14 days after the date when the first notice of appeal was served, or within the time otherwise prescribed by Rule 4(a), whichever period last expires.

In the present case, based upon information in Vivian's answer to Question 15, her notice of the cross-appeal was untimely. Notice of entry of the order on the tolling motion was served on June 16, 2014, and 30 days after that date would have been July 16, 2014. Kirk filed his appeal on July 7, 2014, and 14 days after that date would have been July 21, 2014. Therefore, the deadline for the cross-appeal would have been the later of those two dates, i.e., July 21, 2014. Vivian filed her cross-appeal on August 12, 2014. Therefore, the cross-appeal was too late.

Accordingly, the cross-appeal in Docket 66157 should be dismissed. <u>See Mahaffey v. Investor's Nat. Sec.</u>, 102 Nev. 462, 464, 725 P.2d 1218, 1219 (1986) (failure to file timely notice of cross-appeal is jurisdictional; cross-appeal dismissed).
