This motion is based upon the fact that the seven volumes of the Appendix, which was timely filed on July 24, 2015, was in final format with the pages of the volumes bates stamped until July 22, 2015. Based upon this fact, undersigned counsel used the date of the trial transcript and the page number from that transcript as the record citation when he was preparing the final draft of Mr. Hubbard's opening brief.

On July 24, 2015 at 4:30 p.m., undersigned counsel began the final formatting of the opening brief as required by the Nevada Rules of Appellate Procedure. Counsel believed that the process of changing the transcript citation to the appendix volume and page number should would take several hours and planned to file the opening brief in a timely manner ie before midnight. Unfortunately, as counsel began to update the transcript citations, he realized that he had inadvertently misdated the vast majority of the transcript citations. For explain, counsel found that he had cited the April 16, 2014 transcript when the testimony was actually adduced on April 15, 2014.
