 4 ~~interests with Montoya-Bouvier parties is subject to a Confidentiality Agreement to~~

Mr. Waid's appointment as acting successor Trustee of the Trust is made on a
 5 temporary, interim basis, until further order of the Court. Mr. Waid shall function as the sole
 6 acting Trustee of the Trust, with all powers and authority provided to him under the terms of
 7 the Trust instrument and the applicable Nevada Revised Statutes relating to a trustee's powers.
 8 Consistent with Nevada law, Mr. Waid, as Trustee, shall also honor all fiduciary obligations
 9 owed to all of the beneficiaries of the Trust.

10 In her capacity as the former trustee of the Trust, and until such time that she might be

SUMMARY JUDGMENT

The current proceedings were commenced with the filing on September 27, 2013, of a PETITION FOR DECLARATORY JUDGMENT REGARDING LIMITED INTEREST OF TRUST ASSETS PURSUANT TO NRS 30.040, NRS 153.031(1)(E), AND NRS 164.033(1)(A). This Petition was filed by Jacqueline M. Montoya ("Jacqueline") as Trustee of the MTC Living Trust, and on her behalf and that of Kathryn A. Bouvier ("Kathryn"), her sister, as beneficiaries under the MTC Living Trust. During these proceedings several other Petitions, Motions, and Pleadings have been filed by the parties, including those summarized in the chart attached hereto as Exhibit "A".

1 On December 23, 2014, Jacqueline and Kathryn filed an OPPOSITION TO
2 ELEANOR C. AHERN'S MOTION TO DISMISS PETITION FOR DECLARATORY
3 JUDGMENT FOR FAILURE TO STATE A CLAIM UPON WHICH RELIEF CAN
4 BE GRANTED; AND, COUNTERMOTION OF KATHRYN A. BOUVIER AND
5 JACQUELINE M. MONTOYA FOR SUMMARY JUDGMENT ON PETITION FOR
6 DECLARATORY JUDGMENT, FOR DAMAGES AND ASSESSMENT OF
7 PENALTIES. Thereafter, on January 2, 2015, Eleanor Connell Hartman Ahern
8 ("Eleanor") filed an OMNIBUS OPPOSITION TO (1) PETITION FOR
9 DETERMINATION OF CONSTRUCTION AND INTERPRETATION OF
10 LANGUAGE RELATING TO TRUST NO. 2, AND (2) PETITION FOR
11 CONSTRUCTION EFFECT OF PROBATE COURT ORDER; AND
12 COUNTERMOTION FOR SUMMARY JUDGMENT. The parties agreed at the
13 hearing on January 30, 2015, that their above-denominated Countermotions for
14 Summary Judgment, and the claims and defenses asserted therein, subsumed all of the
15 prior Petitions, Motions and Pleadings, and their defenses and claims asserted therein,
16 as well as those briefed and discussed in the further replies, oppositions and
17 supplements to their Countermotions, ~~as listed on the chart attached hereto as Exhibit~~
18 ~~"A"~~ (other than Jacqueline's and Kathryn's Motion for Leave to Amend Pleadings filed
19 herein on January 12, 2015). Therefore, it was agreed, and the Court recognized, that
20 the parties' claims and defenses in these proceedings could be resolved summarily by
21 the Court in its adjudication of the parties' said Countermotions for Summary
22 Judgment.

23 After reviewing the Countermotions for Summary Judgment, and the
24 presentation of argument for and rebuttal against the Countermotions by the parties, the
25 Court finds as follows:

26 1. A proceeding involving the subject Trust was initially commenced in 2009
27 by Eleanor, as Trustee of the W.N. Connell and Marjorie T. Connell Living Trust,
28 dated May 18, 1972 (herein referred to as the "Trust"), with an unopposed Petition to

1 obtain a Court order clarifying to whom subtrust benefits would be paid upon her
2 death. The Court assumed jurisdiction over the Trust, recognizing that Eleanor, as
3 Trustee, was a Nevada resident, and the Trust provisions provided that it would be
4 administered pursuant to Nevada law. The unopposed Petition was consented to by
5 Jacqueline and Kathryn as contingent beneficiaries of subtrust No. 2 under the Trust,
6 and the Court approved the Petition by Order filed herein on September 4, 2009.
7 Pursuant to the Order, the Trust was reformed to provide that Jacqueline and Kathryn
8 were designated as the beneficiaries under subtrust No. 2 upon the death of Eleanor,
9 which had not theretofore been clearly delineated in the Trust provisions. In addition,
10 Jacqueline was designated as the successor Trustee under the Trust upon the death or
11 removal of Eleanor as the Trustee.

12 2. When the Trust was created in 1972, community property of W.N. Connell
13 ("William") and Marjorie T. Connell ("Marjorie"), along with two parcels of William's
14 separate real property, were transferred to the Trust. One parcel of William's separate
15 property was located in Clark County, Nevada. The other parcel consisted of a parcel
16 of real property and oil, gas and mineral rights relating thereto, located in Upton
17 County, Texas (hereinafter "Texas oil property"). In 1975, William and Marjorie, as
18 Trustees, deeded the Clark County, Nevada, separate property from their Trust to
19 Eleanor, personally, it having a ^{declared} value at the time, based upon the transfer tax paid, of
20 approximately \$55,000.00.

21 3. The dispute in these Trust proceedings relates to the ownership of and
22 entitlement to income from the Texas oil property. At the time of William's death on
23 November 24, 1979, the Texas oil property was the only remaining separate property
24 of William which had been titled in the Trust. The Trust provisions created two
25 subtrusts upon the death of William in 1979 (referred to in the Trust as Trust No. 2 and
26 Trust No. 3, and hereinafter referred to as "subtrust 2" and "subtrust 3"). Income
27 allocated to subtrust 2 was payable to Eleanor during her lifetime. Marjorie was the
28 beneficiary of the income and assets under subtrust 3, including the right during her

1 lifetime, at her election, to receive the assets outright free of trust. She was also given
2 the option of appointing the benefits under subtrust 3 in her Will to whomever she
3 desired. If she failed to remove the assets from subtrust 3 during her lifetime, or to
4 appoint them under her will, the benefits and assets under subtrust 3 would have
5 devolved by default to Eleanor.

6 4. Under the Trust provisions, Article SECOND, Section C.3, subtrust 3 was
7 to be funded with Marjorie's separate property, her share of the community property,
8 and a portion of William's separate property. The portion of William's separate
9 property to be allocated to subtrust 3 is determined by the provisions in Article THIRD
10 of the Trust. These provisions state:

11 "THIRD: MARITAL DEDUCTION. The Trustee shall allocate to Trust No. 3
12 from the Decedent's separate property the fractional share of the said assets which is
13 equal to the maximum marital deduction allowed for federal estate tax purposes . . . In
14 making the computations and allocations of the said property to Trust No. 3 as herein
15 required, the determination of the character and ownership of the said property and the
16 value thereof shall be as finally established for federal estate tax purposes."

17 5. Federal and Texas Estate Tax Returns were filed for William's estate
18 following his death. At the time of these proceedings, a copy of the Federal Estate Tax
19 Return could not be located, even the IRS no longer maintaining a copy thereof.
20 However, a copy of William's Texas Estate Tax Return, and a copy of the Closing
21 Letter for his Federal Estate Tax Return were available. The Texas Estate Tax Return
22 basically duplicated the information provided on the Federal Estate Tax Return, thereby
23 providing how William's estate was allocated and distributed on the Federal Estate Tax
24 Return. Daniel T. Gerety, CPA, an expert witness for Jacqueline and Kathryn, also
25 verified in his Report that the Texas Estate Tax Return used the property allocations
26 made on the Federal Estate Tax Return, and that the two Returns were consistent.

27 6. Under these two Estate Tax Returns, a 64.493% interest in the Texas oil
28 property was allocated to Marjorie, the beneficiary under subtrust 3, and the remaining
35.507% interest in the Texas oil property was allocated to Eleanor, the beneficiary
under subtrust 2. Further, as provided under Article THIRD, quoted above, this

1 allocation of interests in the Texas oil property determined the allocation of interests
2 in that property between subtrust 2 and subtrust 3 under the Trust. For purposes of
3 convenience, the interests in the Texas oil property are rounded to 65% and 35%. The
4 title to the Texas oil property has remained in the main Trust to the present day.

5 7. Upon William's death, Marjorie became the sole acting Trustee for the
6 main Trust, and the subtrusts thereunder. Pursuant to Article SECOND, Section C.6
7 of the Trust, and shortly after William's death in 1980, Eleanor was appointed by
8 Marjorie to be the co-trustee with her over William's separate property remaining in
9 the Trust; that is, over the Texas oil property which had been allocated between
10 subtrust 2 and subtrust 3. A copy of Eleanor's appointment as co-trustee, along with
11 a copy of the Trust, was recorded with the Upton County Texas Recorder's Office.

12 8. Thereafter, Marjorie sent letters to the oil companies with whom the Trust
13 had leases, advising them of William's death and that she and Eleanor were co-trustees
14 over the Texas oil property owned by the Trust. She directed that all further documents
15 which needed to be signed with the oil companies thereafter recognize the need for her
16 and Eleanor's signature.

17 9. From the time of William's death and the allocation of interests in the
18 Texas oil property between subtrust 2 and subtrust 3, until Marjorie's death on May 1,
19 2009, Eleanor was paid 35% of the Texas oil property income and Marjorie was paid
20 the remaining 65% of the income. Each was allocated a K-1 showing her receipt of her
21 share of the income, and each included the income in her annual Federal Income Tax
22 Returns.

23 10. Prior to her death, on January 7, 2008, Marjorie executed her last Will
24 and Testament, wherein she exercised her Power of Appointment over the assets and
25 benefits under subtrust 3, appointing them to Jacqueline and Kathryn as beneficiaries
26 under her MTC Living Trust. Following Marjorie's death, Eleanor, Jacqueline and
27 Kathryn met with David Strauss, Esq, Marjorie's estate planning attorney. Mr. Strauss
28 had previously provided Eleanor with a copy of Marjorie's Will containing the exercise

1 of her Power of Appointment over subtrust 3. In their meeting, he discussed with them
2 Marjorie's exercise of the Power of Appointment transferring to Jacqueline and
3 Kathryn the rights and interests of Marjorie under subtrust 3 of the Trust, thereby
4 entitling Jacqueline and Kathryn to receive the approximate 65% share of income being
5 generated by the Texas oil property going forward.

6 11. No one expressed any objection to what Mr. Strauss had advised them.
7 Thereafter, in the filing of Marjorie's Federal Estate Tax Return, the value of the 65%
8 interest in the Texas oil property allocated to Marjorie under the Trust was included
9 within her Federal taxable estate and Estate Tax Return, increasing the value of her
10 estate to a taxable estate, requiring the payment of over \$140,000.00 in Federal Estate
11 taxes. Most of Marjorie's estate at the time of her death, through her MTC Living
12 Trust, went to Jacqueline and Kathryn in equal shares. However, in addition to several
13 smaller bequests to friends, Marjorie also bequeathed to Eleanor, through the MTC
14 Living Trust, the sum of \$300,000.00.

15 12. From the time of Marjorie's death until approximately June, 2013, the
16 income from the Texas oil property was allocated with Eleanor continuing to receive
17 a 35% share, and Jacqueline and Kathryn receiving the remaining 65% share. In June,
18 2013, Eleanor as the sole acting Trustee of the Trust, stopped further income
19 distributions to Jacqueline and Kathryn, asserting at that time that she was entitled to
20 100% of the income from the Texas oil property. This led to the filing by Jacqueline
21 on September 27, 2013, of the PETITION FOR DECLARATORY JUDGMENT
22 REGARDING LIMITED INTEREST OF TRUST ASSETS PURSUANT TO NRS
23 30.040, NRS 153.031(1)(E), AND NRS 164.033(1)(A).

24 13. Prior to asserting her right to 100% of the income from the Texas oil
25 property in June, 2013, and the cutting off of any further income distributions from the
26 Trust to Jacqueline and Kathryn, Eleanor had never asserted a claim or right to more
27 than 35% of the Texas oil property income as the lifetime beneficiary to income under
28 subtrust 2. However, in her pleadings and documents filed in these proceedings, she

1 claims she was aware of an alleged mistake made in the allocation of the Texas oil
2 property between subtrust 2 and subtrust 3 shortly after the death of William in 1979.
3 However, rather than assert a claim to all of the income, or otherwise make a claim or
4 start a legal action, Eleanor testified that she decided to do nothing. At one point in
5 these proceedings she testified in her pleadings and documents filed that her inaction
6 was motivated by a fear that it would upset Marjorie if she made a claim to more than
7 a 35% interest. She also testified in these proceedings that her inaction was due to the
8 fact she was happy to allow Marjorie to have 65% of the Texas oil property income,
9 feeling she was being generous and helping to support her mother. She asserted the
10 same motivation of generosity as the basis for her allowing Jacqueline and Kathryn to
11 continue receiving a 65% share of the Texas oil property income following the death
12 of Marjorie in 2009, and until her stoppage of income distributions to them in June,
13 2013.

14 14. However, in 1983, as testified to by Robert Hartman in his affidavit, in the
15 course of Eleanor's divorce proceeding from him, her right to only 35% of the Texas
16 oil property income was asserted and relied upon by the Court in its division of
17 property and determination of his support rights and obligations to Eleanor and their
18 two children. Then, a few years later, as shown on an estate planning intake sheet,
19 when Eleanor met with her own estate planning attorney, she advised him that she was
20 only entitled to 35% of the Texas oil property income, and that Marjorie was the owner
21 of the remaining 65% interest.

22 15. Although Eleanor claims she was being generous in giving to Marjorie
23 65% of the Texas oil property income during the balance of Marjorie's life following
24 the death of William in 1979, Marjorie's communications and conduct supported her
25 belief that she owned the rights to 65% of the Texas oil property income as the
26 beneficiary under subtrust 3. This is confirmed in several memoranda/letters prepared
27 by Marjorie, and in the inclusion of the 65% interest in her taxable estate at the time
28 of her death.

1 16. To summarize, no evidence was produced by Eleanor of any claim or
2 assertion being made by her to anyone else to a right to more than 35% of the Texas oil
3 property income from the time of William's death until June, 2013, when she first
4 asserted her claim to 100% of the income by cutting off income distributions to
5 Jacqueline and Kathryn. Further, Marjorie never communicated or acknowledged to
6 anyone else that she was not entitled to 65% of the Texas oil property income, always
7 acting consistently with owning a right to the income under the Trust allocation of the
8 Texas oil property made following William's death in 1979.

9 17. As purported evidence supporting her claim to 100% of the Trust income
10 from the Texas oil property, Eleanor presented copies of Division Orders and Leases
11 between the oil companies and the Trust relating to the Texas oil property. From the
12 time that Eleanor was made co-trustee with Marjorie over William's separate property
13 owned by the Trust until approximately 1989, it appears that in signing the Division
14 Orders and Leases with the oil companies, Marjorie and Eleanor provided their
15 personal Social Security Numbers as a tax identification number when such a number
16 was requested by the oil companies. However, apparently after it was brought to their
17 attention by an oil company that the Trust was the owner of the Texas oil property and
18 not themselves personally, and the oil company requested and recommended that a tax
19 identification number for a Trust be provided, in approximately 1989, Marjorie and
20 Eleanor started providing a tax identification number to the oil companies which had
21 been assigned by the IRS to subtrust 2. They never provided the tax identification
22 number which had been assigned by the IRS to subtrust 3. However, the Court was not
23 provided with any dates on when subtrust 2 and subtrust 3 were first assigned tax
24 identification numbers.

25 18. Nevertheless, and notwithstanding a tax identification number for subtrust
26 2 was the only tax identification number apparently given to the oil companies from
27 and after 1989, in the actual allocation of income received from the Texas oil property,
28 and in the issuance of K-1's and the filing of their Federal Income Tax Returns,

1 Eleanor's share of the income was always a 35% share and Marjorie, while she was
2 alive, always received the remaining 65% share. Following Marjorie's death, the 65%
3 share went to Jacqueline and Kathryn until the cessation of distributions by Eleanor in
4 June, 2013.

5 19. Eleanor also asserted that the Trust was a special Trust created to retain
6 the Texas oil property for the benefit of only William and his blood descendants.
7 However, since at the time of William's death, the only separate property of his that
8 remained in the Trust was the Texas oil property, pursuant to the Trust provisions, a
9 portion of that property had to be allocated to subtrust 3 in order to obtain the
10 maximum Marital Deduction for Federal Estate Tax savings. In following the Trust
11 provisions, the Texas oil property could not all be allocated to subtrust 2. Further,
12 whatever William's intent may have been when he and Marjorie first created the Trust
13 in 1972, by their deeding the Clark County, Nevada, separate property to Eleanor in
14 1975, William knew that the only remaining separate property of his in the Trust at the
15 time of his death would be the Texas oil property.

16 20. Lastly, in support of her position, Eleanor asserted that Jacqueline and
17 Kathryn acknowledged that she owned rights to all of the income from the Texas oil
18 property by their consents to and verifications of the 2009 Petition Eleanor filed to
19 clarify ownership of subtrust 2 upon her death. Eleanor asserted that in this Petition
20 there are statements averring that she owned the rights to all of the Texas oil property
21 income. However, the Petition's language can also be read as asserting that Eleanor's
22 right to income from the Texas oil property only refers to her 35% interest. More
23 significantly, the 2009 Petition was not filed to clarify rights to the Texas oil property
24 income. Rather, it was a consentient Petition with the purpose only of clarifying
25 entitlement to the benefits of subtrust 2 upon Eleanor's death, and to designate a
26 successor Trustee for the Trust upon her death.

27 21. Based upon the foregoing undisputed facts presented to the Court with the
28 Affidavits and documentary evidence submitted by the parties with their

1 Countermotions and briefs, and from the argument of counsel at the hearing, the Court
2 finds that Eleanor's interest in the Texas oil property income, as the beneficiary under
3 subtrust 2 of the Trust, is limited to a 35% share, and her claim to all of the income is
4 not supported in any way by the facts in this case. The remaining 65% share belongs
5 to subtrust 3 and Jacqueline and Kathryn, equally, as the beneficiaries under the MTC
6 Living Trust, as bequeathed and appointed to them by Marjorie in her Will. While title
7 to the Texas oil property remains titled in the main Trust, in the event a division of the
8 title now needs to be made between the two subtrusts, such division should be made
9 as recognized in the Trust administration, with the filing of William's Estate Tax
10 Returns, and the allocation between the subtrusts resulting therefrom, with a 35%
11 interest being deeded to subtrust 2, and a 65% interest being deeded to subtrust 3 (and
12 thereafter said 65% interest being deeded to the MTC Living Trust, with Jacqueline and
13 Kathryn as equal beneficiaries, should that be their request). Accordingly, Jacqueline's
14 and Kathryn's Countermotion for Summary Judgment regarding ownership of the
15 Texas oil property should be granted; and, Eleanor's Countermotion for Summary
16 Judgment should be denied.

17 22. While the Court finds that Jacqueline's and Kathryn's claim to 65% of the
18 Texas oil property and income is supported by the facts and merits of the case, and that
19 Eleanor's claim to more than 35% is not supported by the facts and merits of the case,
20 regardless of the merits of Eleanor's position, her claim to more than 35% of the
21 income from the Texas oil property cannot be supported or allowed for equitable
22 reasons because she has been guilty of laches in asserting her claim. Her assertion of
23 a claim to 100% of the income in June, 2013, makes no sense after failing in anyway
24 to assert a claim to more than 35% of the income prior to that time. During
25 approximately 34 years, from the death of William and her admitted awareness of the
26 allocation of the Texas oil property under the Trust provisions, until her first assertion
27 of a claim to more than 35% of the income in June, 2013, Eleanor never filed a claim
28 in any court, or otherwise asserted a claim or right to more than 35% of the income.

1 During this time, material documentary evidence, such as William's Federal Estate Tax
2 Return has been lost. During this time key witnesses, such as the accountant and other
3 professionals who prepared and filed William's Estate Tax Returns, as well as Marjorie
4 herself, have died. During this time period Jacqueline and Kathryn, and Marjorie while
5 she was living, made decisions affecting their personal and financial well-being in
6 reliance upon Eleanor's acceptance of the Texas oil property allocation under the Trust,
7 based upon her conduct and failure to make any challenge of the allocation. Eleanor's
8 claim to all of the income first asserted in approximately June, 2013, is made far too
9 late and has caused prejudice to Jacqueline and Kathryn because of the loss of evidence
10 and testimony of key witnesses, clearly requiring a rejection of Eleanor's position and
11 claim in these proceedings under the equitable doctrine of laches.

12 23. Concern was expressed by Jacqueline and Kathryn to Eleanor, through
13 counsel, during 2014 as to the status of funds Eleanor was required to hold in trust on
14 their behalf should the Court rule in their favor in these proceedings. An accounting
15 was requested from Eleanor's former counsel, and they were in the process of preparing
16 the same when Eleanor dismissed her former counsel and engaged new counsel.
17 *is ordered to provide by March 2, 2015, as*
Eleanor needs to follow through with the providing of this accounting for the Texas oil
18 property income, including the providing of information to Jacqueline and Kathryn
19 showing the total income received, expenses incurred, and distributions made of the
20 income from the beginning of 2012 to the present. Any income which should have
21 been distributed to Jacqueline and Kathryn during this time period, shall be accounted
22 for and reimbursed to them by Eleanor within 30 days from the date this judgment is
23 entered.

24 24. As noted in the chart attached hereto as Exhibit "A", Jacqueline and
25 Kathryn filed a Motion for Leave to Amend Pleadings, which was set for hearing on
26 January 30, 2015. As noted in this Motion and the Supplement thereto, they filed their
27 Motion out of an abundance of caution in that Eleanor in her briefing in support of her
28 Countermotion indicated that she did not feel Jacqueline and Kathryn had properly

1 pleaded all of their claims for relief and defenses for consideration by the Court at the
2 scheduled hearing. While Jacqueline and Kathryn disagreed with Eleanor's pleading
3 concerns, the pleadings and hearings in these proceedings had become disjointed in that
4 a companion Will Contest case, filed with this Court by Eleanor in Case No. P-14-
5 080595-E, intervened to suspend and continue the Trust matters until after the Will
6 Contest case was resolved. The Will Contest was resolved with a Stipulation for
7 Dismissal in early January, 2015. Further, Eleanor has been represented by three
8 different sets of attorney's in these proceedings. Her current attorneys only
9 commencing representation in late November, 2014, and they were not initially familiar
10 with the prior proceedings in this case and the effect of the Will Contest case
11 intervention. In any event, the Court finds that the initial pleadings filed on behalf of
12 Jacqueline and Kathryn in these proceedings properly plead the claims for relief and
13 the defense that the Court has relied upon in granting Judgment to them in these
14 proceedings. Eleanor clearly had notice of the pleadings and in fact the parties
15 negotiated over all of the claims for relief and the affirmative defenses alleged by
16 Jacqueline and Kathryn in concerted settlement negotiations in October, 2014, and such
17 claims and defenses were contained in the several Petitions and Motions filed during
18 the proceedings. In particular the defense of laches was mentioned in the context of
19 equitable defenses mentioned in the initial pleading, and was the subject of a Motion
20 to Dismiss and resolve the case summarily both in late 2013 and in early 2014.
21 Accordingly, the Court finds that there is no reason to file an Amended Pleading in
22 these proceedings and Jacqueline and Kathryn's Motion seeking permission to file the
23 same is considered moot and resolved.

24 25. There are still some claims and issues that the Court is not resolving at this
25 time. Eleanor filed a counterclaim for wrongful interference with contract with her
26 Answer and Counterclaim filed herein on February 10, 2014. The Court finds that this
27 Counterclaim should be dismissed without prejudice at this time, since the issues
28 therein were not addressed by the Court in the January 30, 2015, hearing, but it seems

1 that the issues would be resolved with its decision herein on the Countermotions.
2 Nevertheless, if Eleanor believes she has a valid claim still against Jacqueline for
3 wrongful interference with contract, as asserted in her Answer and Counterclaim, she
4 is free to reassert the same.

5 26. Each of the parties asserted a claim against the other in these proceedings
6 seeking to have the Court enforce the no-contest clause contained in the Trust against
7 the other party. The Court finds that the positions of each of the parties, seeking the
8 correct interpretation of the Trust provisions as to entitlement to the Texas oil property,
9 were not asserted in bad faith, and that therefore good cause to impose the no-contest
10 penalties does not exist and such claims are denied with respect to both parties, Eleanor
11 on the one hand, and Jacqueline and Kathryn on the other hand.

12 27. There still remains the issues and concerns of who will serve hereafter as
13 the Trustee of the Trust, and whether or not the interests of subtrust 2 and subtrust 3
14 in the Texas oil property should now be formally split and allocated with deeds from
15 the main Trust to the subtrusts, so the parties can go their separate ways in dealing with
16 their interests in the Texas oil properties, subject to the terms of the Trust with respect
17 to subtrust 2. Clearly, under the Trust provisions, the beneficiaries under subtrust 3 are
18 granted the right to remove their interest in the Texas oil property out of the main Trust
19 and subtrust 3, to be owned independently by the MTC Living Trust and Jacqueline
20 and Kathryn as beneficiaries thereunder. However, the Court is directing the parties
21 to submit to the Court, on or before March 2, 2015, information regarding the
22 feasibility and effect of now splitting the Texas oil property between subtrust 2 and
23 subtrust 3 (or the MTC Living Trust), and whether or not such division of interests
24 could adversely affect the value and future ownership of the interests hereafter. The
25 Court will set a hearing to consider this issue on March 20, 2015, at 10:00a.m.

26 28. With respect to whether or not Eleanor should be able to continue serving
27 as Trustee, to address both Jacqueline's and Kathryn's position that she should be
28 removed for breach of her duties as Trustee, and Eleanor's position that she is not

1 disqualified from serving, the Court also is directing the parties to provide a brief in
2 support of their positions, filed on or before March 2, 2015, with the issue to then be
3 addressed by the Court at the hearing on March 20, 2015.

4 29. Lastly, with respect to the claim Jacqueline and Kathryn have made for an
5 award of attorney's fees against Eleanor, the Court is directing that the parties file with
6 their briefs due on or before March 2, 2015, their argument and basis for their positions
7 on the award of attorney's fees and costs against Eleanor for the Court to then resolve
8 at the hearing on March 20, 2015.

9 30. In addition to the matters addressed at the hearing on January 30, 2015,
10 there is a pending appeal to the Nevada Supreme Court, assigned Case No. 66231, filed
11 by Eleanor, appealing a portion of the Court's Order in these proceedings entered on
12 July 7, 2014. With the resolution of issues in this case as herein provided, the matter
13 on appeal is now rendered moot. Therefore, the parties should submit a stipulation to
14 the Nevada Supreme Court dismissing that appeal.

15 JUGMENT

16 Pursuant to NRCP Rule 56, the Court finds that the pleadings and other
17 documents filed herein, together with the affidavits and documentary evidence
18 presented, show there is no genuine issue as to any material fact and that Jacqueline
19 and Kathryn are entitled to judgment against Eleanor as a matter of law in these
20 proceedings. Therefore, and based upon the foregoing findings, good cause exists to
21 now render judgment against Eleanor, in favor of Jacqueline and Kathryn, as follows:

22 A. Jacqueline's and Kathryn's Countermotion for Summary Judgment is
23 granted in part as hereinafter provided. The Court hereby declares, adjudges and
24 determines that the allocation of interests in the Texas oil property between subtrust 2
25 and subtrust 3, under the W.N. Connell and Marjorie T. Connell Living Trust, dated
26 May 18, 1972, was properly made under the Trust provisions, with subtrust 2 receiving
27 a 35.507% interest in the Texas oil property and subtrust 3 receiving a 64.493%
28 interest in the Texas oil property.

1 B. The Court adjudges and determines that even if the allocation of the Texas
2 oil property made following the death of William in 1979, in conjunction with the
3 filing of his Federal and Texas Estate Tax Returns, was not properly or accurately made
4 between the two subtrusts, Eleanor's claim and effort to now challenge the allocation
5 and assert an interest greater than 35.507% in the Texas oil property being in subtrust
6 2, is too late and barred under the doctrine of laches, thereby making the actual division
7 made final and binding upon her.

8 C. Eleanor's Countermotion for Summary Judgment is hereby denied.

9 D. On or before March 2, 2015, Eleanor shall provide to Jacqueline and
10 Kathryn an accounting of the Texas oil property income received by the Trust from
11 January 1, 2012, through the entry of this Summary Judgment, showing the total
12 income received, expenses incurred, and any distributions made of the income. Within
13 30 days following the entry of this Summary Judgment, Eleanor shall reimburse and
14 pay to Jacqueline and Kathryn any portion of their 65% share of the Texas oil property
15 income which was not distributed to them during this period of time. From and after
16 the entry of this Summary Judgment, 35% of the Texas oil property income shall be
17 distributed to Eleanor as beneficiary under subtrust 2, and 65% of the income shall be
18 distributed equally between Jacqueline and Kathryn as beneficiaries under subtrust 3
19 and the MTC Living Trust.

20 E. Eleanor's Counterclaim for wrongful interference with contract asserted
21 with her Answer and Counterclaim filed herein on February 10, 2014, is hereby
22 dismissed without prejudice.

23 F. The Court adjudges and determines that the positions of each of the
24 parties, seeking the correct interpretation of the Trust provisions as to entitlement to
25 the Texas oil property, were not asserted in bad faith, and that therefore good cause to
26 impose the no-contest penalties does not exist and such claims, both Eleanor's claim
27 on the one hand, and Jacqueline's and Kathryn's claim on the other hand, are denied
28 with prejudice.

1 G. Each of the parties is directed to file further briefing on the following
2 issues with the Court on or before March 2, 2015, which issues and matters will be
3 resolved by the Court at the next hearing in these proceedings, hereby set on March 20,
4 2015, at 10:00a.m.:

5 1) In the event there is no formal splitting of the Texas oil property between
6 subtrust 2 and subtrust 3 at this time, is there cause to remove Eleanor as Trustee and
7 appoint Jacqueline as the successor Trustee of the Trust and the subtrusts thereunder?
8 If cause does not exist for Eleanor's removal, would it still be better to appoint a
9 neutral successor Trustee?

10 2) Should the interests of subtrust 2 and subtrust 3 in the Texas oil property
11 now be formally split and allocated with deeds from the main Trust to the subtrusts, so
12 the parties can go their separate ways in dealing with their interests in the Texas oil
13 properties, subject to the terms of the Trust with respect to subtrust 2? The Court wants
14 the parties to provide recommendations from qualified persons knowledgeable with
15 respect to the Texas oil and mineral rights and the potential harm or benefit that could
16 result in a splitting of the interests between the parties, and whether or not such
17 division of interests could adversely affect the value and future ownership of the
18 interests hereafter.

19 3) Lastly, with respect to the claim Jacqueline and Kathryn have made for an
20 award of attorney's fees against Eleanor, the Court directs the parties to provide their
21 argument and basis for their positions on the award of attorney's fees and costs against
22 Eleanor in briefing filed on or before March 2, 2015, for the Court to then resolve at
23 the scheduled hearing on March 20, 2015.

24 H. The parties shall each sign a Stipulation and Order for Dismissal of the
25 Appeal presently pending in Nevada Supreme Court Case No. 66231, filed by Eleanor,
26 appealing a portion of the Court's Order in these proceedings entered on July 7, 2014.

27 I. The Court retains jurisdiction over the Trust pending the finalization and
28 resolution of the remaining issues mentioned above, to be addressed hereafter at the

hearing scheduled on March 20, 2015, at 10:00a.m. Until that date, Eleanor shall continue to exercise and fulfill her duties as Trustee of the Trust, and the parties shall all cooperate, in the best interest of the Trust and its beneficiaries, in any dealings with the oil companies affecting the Texas oil property.

SO ORDERED AND ADJUDGED this 15 day of February, 2015.







SUMMARY JUDGMENT

The current proceedings were commenced with the filing on September 27, 2013, of a PETITION FOR DECLARATORY JUDGMENT REGARDING LIMITED INTEREST OF TRUST ASSETS PURSUANT TO NRS 30.040, NRS 153.031(1)(E), AND NRS 164.033(1)(A). This Petition was filed by Jacqueline M. Montoya ("Jacqueline") as Trustee of the MTC Living Trust, and on her behalf and that of Kathryn A. Bouvier ("Kathryn"), her sister, as beneficiaries under the MTC Living Trust. During these proceedings several other Petitions, Motions, and Pleadings have been filed by the parties, including those summarized in the chart attached hereto as Exhibit "A".

On December 23, 2014, Jacqueline and Kathryn filed an OPPOSITION TO ELEANOR C. AHERN'S MOTION TO DISMISS PETITION FOR DECLARATORY JUDGMENT FOR FAILURE TO STATE A CLAIM UPON WHICH RELIEF CAN BE GRANTED; AND, COUNTERMOTION OF KATHRYN A. BOUVIER AND JACQUELINE M. MONTOYA FOR SUMMARY JUDGMENT ON PETITION FOR DECLARATORY JUDGMENT, FOR DAMAGES AND ASSESSMENT OF PENALTIES. Thereafter, on January 2, 2015, Eleanor Connell Hartman Ahern ("Eleanor") filed an OMNIBUS OPPOSITION TO (1) PETITION FOR DETERMINATION OF CONSTRUCTION AND INTERPRETATION OF LANGUAGE RELATING TO TRUST NO. 2, AND (2) PETITION FOR CONSTRUCTION EFFECT OF PROBATE COURT ORDER; AND COUNTERMOTION FOR SUMMARY JUDGMENT. The parties agreed at the hearing on January 30, 2015, that their above-denominated Countermotions for Summary Judgment, and the claims and defenses asserted therein, subsumed all of the prior Petitions, Motions and Pleadings, and their defenses and claims asserted therein, as well as those briefed and discussed in the further replies, oppositions and supplements to their Countermotions, ~~as listed on the chart attached hereto as Exhibit "A"~~ (other than Jacqueline's and Kathryn's Motion for Leave to Amend Pleadings filed herein on January 12, 2015). Therefore, it was agreed, and the Court recognized, that the parties' claims and defenses in these proceedings could be resolved summarily by the Court in its adjudication of the parties' said Countermotions for Summary Judgment.

After reviewing the Countermotions for Summary Judgment, and the presentation of argument for and rebuttal against the Countermotions by the parties, the Court finds as follows:

1. A proceeding involving the subject Trust was initially commenced in 2009 by Eleanor, as Trustee of the W.N. Connell and Marjorie T. Connell Living Trust, dated May 18, 1972 (herein referred to as the "Trust"), with an unopposed Petition to

1 obtain a Court order clarifying to whom subtrust benefits would be paid upon her
2 death. The Court assumed jurisdiction over the Trust, recognizing that Eleanor, as
3 Trustee, was a Nevada resident, and the Trust provisions provided that it would be
4 administered pursuant to Nevada law. The unopposed Petition was consented to by
5 Jacqueline and Kathryn as contingent beneficiaries of subtrust No. 2 under the Trust,
6 and the Court approved the Petition by Order filed herein on September 4, 2009.
7 Pursuant to the Order, the Trust was reformed to provide that Jacqueline and Kathryn
8 were designated as the beneficiaries under subtrust No. 2 upon the death of Eleanor,
9 which had not theretofore been clearly delineated in the Trust provisions. In addition,
10 Jacqueline was designated as the successor Trustee under the Trust upon the death or
11 removal of Eleanor as the Trustee.

12 2. When the Trust was created in 1972, community property of W.N. Connell
13 ("William") and Marjorie T. Connell ("Marjorie"), along with two parcels of William's
14 separate real property, were transferred to the Trust. One parcel of William's separate
15 property was located in Clark County, Nevada. The other parcel consisted of a parcel
16 of real property and oil, gas and mineral rights relating thereto, located in Upton
17 County, Texas (hereinafter "Texas oil property"). In 1975, William and Marjorie, as
18 Trustees, deeded the Clark County, Nevada, separate property from their Trust to
19 Eleanor, personally, it having a ^{declared} value at the time, based upon the transfer tax paid, of
20 approximately \$55,000.00.

21 3. The dispute in these Trust proceedings relates to the ownership of and
22 entitlement to income from the Texas oil property. At the time of William's death on
23 November 24, 1979, the Texas oil property was the only remaining separate property
24 of William which had been titled in the Trust. The Trust provisions created two
25 subtrusts upon the death of William in 1979 (referred to in the Trust as Trust No. 2 and
26 Trust No. 3, and hereinafter referred to as "subtrust 2" and "subtrust 3"). Income
27 allocated to subtrust 2 was payable to Eleanor during her lifetime. Marjorie was the
28 beneficiary of the income and assets under subtrust 3, including the right during her

1 lifetime, at her election, to receive the assets outright free of trust. She was also given
2 the option of appointing the benefits under subtrust 3 in her Will to whomever she
3 desired. If she failed to remove the assets from subtrust 3 during her lifetime, or to
4 appoint them under her will, the benefits and assets under subtrust 3 would have
5 devolved by default to Eleanor.

6 4. Under the Trust provisions, Article SECOND, Section C.3, subtrust 3 was
7 to be funded with Marjorie's separate property, her share of the community property,
8 and a portion of William's separate property. The portion of William's separate
9 property to be allocated to subtrust 3 is determined by the provisions in Article THIRD
10 of the Trust. These provisions state:

11 "THIRD: MARITAL DEDUCTION. The Trustee shall allocate to Trust No. 3
12 from the Decedent's separate property the fractional share of the said assets which is
13 equal to the maximum marital deduction allowed for federal estate tax purposes . . . In
14 making the computations and allocations of the said property to Trust No. 3 as herein
15 required, the determination of the character and ownership of the said property and the
16 value thereof shall be as finally established for federal estate tax purposes."

17 5. Federal and Texas Estate Tax Returns were filed for William's estate
18 following his death. At the time of these proceedings, a copy of the Federal Estate Tax
19 Return could not be located, even the IRS no longer maintaining a copy thereof.
20 However, a copy of William's Texas Estate Tax Return, and a copy of the Closing
21 Letter for his Federal Estate Tax Return were available. The Texas Estate Tax Return
22 basically duplicated the information provided on the Federal Estate Tax Return, thereby
23 providing how William's estate was allocated and distributed on the Federal Estate Tax
24 Return. Daniel T. Gerety, CPA, an expert witness for Jacqueline and Kathryn, also
25 verified in his Report that the Texas Estate Tax Return used the property allocations
26 made on the Federal Estate Tax Return, and that the two Returns were consistent.

27 6. Under these two Estate Tax Returns, a 64.493% interest in the Texas oil
28 property was allocated to Marjorie, the beneficiary under subtrust 3, and the remaining
35.507% interest in the Texas oil property was allocated to Eleanor, the beneficiary
under subtrust 2. Further, as provided under Article THIRD, quoted above, this

1 allocation of interests in the Texas oil property determined the allocation of interests
2 in that property between subtrust 2 and subtrust 3 under the Trust. For purposes of
3 convenience, the interests in the Texas oil property are rounded to 65% and 35%. The
4 title to the Texas oil property has remained in the main Trust to the present day.

5 7. Upon William's death, Marjorie became the sole acting Trustee for the
6 main Trust, and the subtrusts thereunder. Pursuant to Article SECOND, Section C.6
7 of the Trust, and shortly after William's death in 1980, Eleanor was appointed by
8 Marjorie to be the co-trustee with her over William's separate property remaining in
9 the Trust; that is, over the Texas oil property which had been allocated between
10 subtrust 2 and subtrust 3. A copy of Eleanor's appointment as co-trustee, along with
11 a copy of the Trust, was recorded with the Upton County Texas Recorder's Office.

12 8. Thereafter, Marjorie sent letters to the oil companies with whom the Trust
13 had leases, advising them of William's death and that she and Eleanor were co-trustees
14 over the Texas oil property owned by the Trust. She directed that all further documents
15 which needed to be signed with the oil companies thereafter recognize the need for her
16 and Eleanor's signature.

17 9. From the time of William's death and the allocation of interests in the
18 Texas oil property between subtrust 2 and subtrust 3, until Marjorie's death on May 1,
19 2009, Eleanor was paid 35% of the Texas oil property income and Marjorie was paid
20 the remaining 65% of the income. Each was allocated a K-1 showing her receipt of her
21 share of the income, and each included the income in her annual Federal Income Tax
22 Returns.

23 10. Prior to her death, on January 7, 2008, Marjorie executed her last Will
24 and Testament, wherein she exercised her Power of Appointment over the assets and
25 benefits under subtrust 3, appointing them to Jacqueline and Kathryn as beneficiaries
26 under her MTC Living Trust. Following Marjorie's death, Eleanor, Jacqueline and
27 Kathryn met with David Strauss, Esq, Marjorie's estate planning attorney. Mr. Strauss
28 had previously provided Eleanor with a copy of Marjorie's Will containing the exercise

1 of her Power of Appointment over subtrust 3. In their meeting, he discussed with them
2 Marjorie's exercise of the Power of Appointment transferring to Jacqueline and
3 Kathryn the rights and interests of Marjorie under subtrust 3 of the Trust, thereby
4 entitling Jacqueline and Kathryn to receive the approximate 65% share of income being
5 generated by the Texas oil property going forward.

6 11. No one expressed any objection to what Mr. Strauss had advised them.
7 Thereafter, in the filing of Marjorie's Federal Estate Tax Return, the value of the 65%
8 interest in the Texas oil property allocated to Marjorie under the Trust was included
9 within her Federal taxable estate and Estate Tax Return, increasing the value of her
10 estate to a taxable estate, requiring the payment of over \$140,000.00 in Federal Estate
11 taxes. Most of Marjorie's estate at the time of her death, through her MTC Living
12 Trust, went to Jacqueline and Kathryn in equal shares. However, in addition to several
13 smaller bequests to friends, Marjorie also bequeathed to Eleanor, through the MTC
14 Living Trust, the sum of \$300,000.00.

15 12. From the time of Marjorie's death until approximately June, 2013, the
16 income from the Texas oil property was allocated with Eleanor continuing to receive
17 a 35% share, and Jacqueline and Kathryn receiving the remaining 65% share. In June,
18 2013, Eleanor as the sole acting Trustee of the Trust, stopped further income
19 distributions to Jacqueline and Kathryn, asserting at that time that she was entitled to
20 100% of the income from the Texas oil property. This led to the filing by Jacqueline
21 on September 27, 2013, of the PETITION FOR DECLARATORY JUDGMENT
22 REGARDING LIMITED INTEREST OF TRUST ASSETS PURSUANT TO NRS
23 30.040, NRS 153.031(1)(E), AND NRS 164.033(1)(A).

24 13. Prior to asserting her right to 100% of the income from the Texas oil
25 property in June, 2013, and the cutting off of any further income distributions from the
26 Trust to Jacqueline and Kathryn, Eleanor had never asserted a claim or right to more
27 than 35% of the Texas oil property income as the lifetime beneficiary to income under
28 subtrust 2. However, in her pleadings and documents filed in these proceedings, she

1 claims she was aware of an alleged mistake made in the allocation of the Texas oil
2 property between subtrust 2 and subtrust 3 shortly after the death of William in 1979.
3 However, rather than assert a claim to all of the income, or otherwise make a claim or
4 start a legal action, Eleanor testified that she decided to do nothing. At one point in
5 these proceedings she testified in her pleadings and documents filed that her inaction
6 was motivated by a fear that it would upset Marjorie if she made a claim to more than
7 a 35% interest. She also testified in these proceedings that her inaction was due to the
8 fact she was happy to allow Marjorie to have 65% of the Texas oil property income,
9 feeling she was being generous and helping to support her mother. She asserted the
10 same motivation of generosity as the basis for her allowing Jacqueline and Kathryn to
11 continue receiving a 65% share of the Texas oil property income following the death
12 of Marjorie in 2009, and until her stoppage of income distributions to them in June,
13 2013.

14 14. However, in 1983, as testified to by Robert Hartman in his affidavit, in the
15 course of Eleanor's divorce proceeding from him, her right to only 35% of the Texas
16 oil property income was asserted and relied upon by the Court in its division of
17 property and determination of his support rights and obligations to Eleanor and their
18 two children. Then, a few years later, as shown on an estate planning intake sheet,
19 when Eleanor met with her own estate planning attorney, she advised him that she was
20 only entitled to 35% of the Texas oil property income, and that Marjorie was the owner
21 of the remaining 65% interest.

22 15. Although Eleanor claims she was being generous in giving to Marjorie
23 65% of the Texas oil property income during the balance of Marjorie's life following
24 the death of William in 1979, Marjorie's communications and conduct supported her
25 belief that she owned the rights to 65% of the Texas oil property income as the
26 beneficiary under subtrust 3. This is confirmed in several memoranda/letters prepared
27 by Marjorie, and in the inclusion of the 65% interest in her taxable estate at the time
28 of her death.

1 16. To summarize, no evidence was produced by Eleanor of any claim or
2 assertion being made by her to anyone else to a right to more than 35% of the Texas oil
3 property income from the time of William's death until June, 2013, when she first
4 asserted her claim to 100% of the income by cutting off income distributions to
5 Jacqueline and Kathryn. Further, Marjorie never communicated or acknowledged to
6 anyone else that she was not entitled to 65% of the Texas oil property income, always
7 acting consistently with owning a right to the income under the Trust allocation of the
8 Texas oil property made following William's death in 1979.

9 17. As purported evidence supporting her claim to 100% of the Trust income
10 from the Texas oil property, Eleanor presented copies of Division Orders and Leases
11 between the oil companies and the Trust relating to the Texas oil property. From the
12 time that Eleanor was made co-trustee with Marjorie over William's separate property
13 owned by the Trust until approximately 1989, it appears that in signing the Division
14 Orders and Leases with the oil companies, Marjorie and Eleanor provided their
15 personal Social Security Numbers as a tax identification number when such a number
16 was requested by the oil companies. However, apparently after it was brought to their
17 attention by an oil company that the Trust was the owner of the Texas oil property and
18 not themselves personally, and the oil company requested and recommended that a tax
19 identification number for a Trust be provided, in approximately 1989, Marjorie and
20 Eleanor started providing a tax identification number to the oil companies which had
21 been assigned by the IRS to subtrust 2. They never provided the tax identification
22 number which had been assigned by the IRS to subtrust 3. However, the Court was not
23 provided with any dates on when subtrust 2 and subtrust 3 were first assigned tax
24 identification numbers.

25 18. Nevertheless, and notwithstanding a tax identification number for subtrust
26 2 was the only tax identification number apparently given to the oil companies from
27 and after 1989, in the actual allocation of income received from the Texas oil property,
28 and in the issuance of K-1's and the filing of their Federal Income Tax Returns,

1 Eleanor's share of the income was always a 35% share and Marjorie, while she was
2 alive, always received the remaining 65% share. Following Marjorie's death, the 65%
3 share went to Jacqueline and Kathryn until the cessation of distributions by Eleanor in
4 June, 2013.

5 19. Eleanor also asserted that the Trust was a special Trust created to retain
6 the Texas oil property for the benefit of only William and his blood descendants.
7 However, since at the time of William's death, the only separate property of his that
8 remained in the Trust was the Texas oil property, pursuant to the Trust provisions, a
9 portion of that property had to be allocated to subtrust 3 in order to obtain the
10 maximum Marital Deduction for Federal Estate Tax savings. In following the Trust
11 provisions, the Texas oil property could not all be allocated to subtrust 2. Further,
12 whatever William's intent may have been when he and Marjorie first created the Trust
13 in 1972, by their deeding the Clark County, Nevada, separate property to Eleanor in
14 1975, William knew that the only remaining separate property of his in the Trust at the
15 time of his death would be the Texas oil property.

16 20. Lastly, in support of her position, Eleanor asserted that Jacqueline and
17 Kathryn acknowledged that she owned rights to all of the income from the Texas oil
18 property by their consents to and verifications of the 2009 Petition Eleanor filed to
19 clarify ownership of subtrust 2 upon her death. Eleanor asserted that in this Petition
20 there are statements averring that she owned the rights to all of the Texas oil property
21 income. However, the Petition's language can also be read as asserting that Eleanor's
22 right to income from the Texas oil property only refers to her 35% interest. More
23 significantly, the 2009 Petition was not filed to clarify rights to the Texas oil property
24 income. Rather, it was a consentient Petition with the purpose only of clarifying
25 entitlement to the benefits of subtrust 2 upon Eleanor's death, and to designate a
26 successor Trustee for the Trust upon her death.

27 21. Based upon the foregoing undisputed facts presented to the Court with the
28 Affidavits and documentary evidence submitted by the parties with their

1 Countermotions and briefs, and from the argument of counsel at the hearing, the Court
2 finds that Eleanor's interest in the Texas oil property income, as the beneficiary under
3 subtrust 2 of the Trust, is limited to a 35% share, and her claim to all of the income is
4 not supported in any way by the facts in this case. The remaining 65% share belongs
5 to subtrust 3 and Jacqueline and Kathryn, equally, as the beneficiaries under the MTC
6 Living Trust, as bequeathed and appointed to them by Marjorie in her Will. While title
7 to the Texas oil property remains titled in the main Trust, in the event a division of the
8 title now needs to be made between the two subtrusts, such division should be made
9 as recognized in the Trust administration, with the filing of William's Estate Tax
10 Returns, and the allocation between the subtrusts resulting therefrom, with a 35%
11 interest being deeded to subtrust 2, and a 65% interest being deeded to subtrust 3 (and
12 thereafter said 65% interest being deeded to the MTC Living Trust, with Jacqueline and
13 Kathryn as equal beneficiaries, should that be their request). Accordingly, Jacqueline's
14 and Kathryn's Countermotion for Summary Judgment regarding ownership of the
15 Texas oil property should be granted; and, Eleanor's Countermotion for Summary
16 Judgment should be denied.

17 22. While the Court finds that Jacqueline's and Kathryn's claim to 65% of the
18 Texas oil property and income is supported by the facts and merits of the case, and that
19 Eleanor's claim to more than 35% is not supported by the facts and merits of the case,
20 regardless of the merits of Eleanor's position, her claim to more than 35% of the
21 income from the Texas oil property cannot be supported or allowed for equitable
22 reasons because she has been guilty of laches in asserting her claim. Her assertion of
23 a claim to 100% of the income in June, 2013, makes no sense after failing in anyway
24 to assert a claim to more than 35% of the income prior to that time. During
25 approximately 34 years, from the death of William and her admitted awareness of the
26 allocation of the Texas oil property under the Trust provisions, until her first assertion
27 of a claim to more than 35% of the income in June, 2013, Eleanor never filed a claim
28 in any court, or otherwise asserted a claim or right to more than 35% of the income.

1 During this time, material documentary evidence, such as William's Federal Estate Tax
2 Return has been lost. During this time key witnesses, such as the accountant and other
3 professionals who prepared and filed William's Estate Tax Returns, as well as Marjorie
4 herself, have died. During this time period Jacqueline and Kathryn, and Marjorie while
5 she was living, made decisions affecting their personal and financial well-being in
6 reliance upon Eleanor's acceptance of the Texas oil property allocation under the Trust,
7 based upon her conduct and failure to make any challenge of the allocation. Eleanor's
8 claim to all of the income first asserted in approximately June, 2013, is made far too
9 late and has caused prejudice to Jacqueline and Kathryn because of the loss of evidence
10 and testimony of key witnesses, clearly requiring a rejection of Eleanor's position and
11 claim in these proceedings under the equitable doctrine of laches.

12 23. Concern was expressed by Jacqueline and Kathryn to Eleanor, through
13 counsel, during 2014 as to the status of funds Eleanor was required to hold in trust on
14 their behalf should the Court rule in their favor in these proceedings. An accounting
15 was requested from Eleanor's former counsel, and they were in the process of preparing
16 the same when Eleanor dismissed her former counsel and engaged new counsel.
17 *is ordered to provide by March 2, 2015, and*
18 Eleanor needs to follow through with the providing of this accounting for the Texas oil
19 property income, including the providing of information to Jacqueline and Kathryn
20 showing the total income received, expenses incurred, and distributions made of the
21 income from the beginning of 2012 to the present. Any income which should have
22 been distributed to Jacqueline and Kathryn during this time period, shall be accounted
23 for and reimbursed to them by Eleanor within 30 days from the date this judgment is
24 entered.

25 24. As noted in the chart attached hereto as Exhibit "A", Jacqueline and
26 Kathryn filed a Motion for Leave to Amend Pleadings, which was set for hearing on
27 January 30, 2015. As noted in this Motion and the Supplement thereto, they filed their
28 Motion out of an abundance of caution in that Eleanor in her briefing in support of her
Counter-motion indicated that she did not feel Jacqueline and Kathryn had properly

1 pleaded all of their claims for relief and defenses for consideration by the Court at the
2 scheduled hearing. While Jacqueline and Kathryn disagreed with Eleanor's pleading
3 concerns, the pleadings and hearings in these proceedings had become disjointed in that
4 a companion Will Contest case, filed with this Court by Eleanor in Case No. P-14-
5 080595-E, intervened to suspend and continue the Trust matters until after the Will
6 Contest case was resolved. The Will Contest was resolved with a Stipulation for
7 Dismissal in early January, 2015. Further, Eleanor has been represented by three
8 different sets of attorney's in these proceedings. Her current attorneys only
9 commencing representation in late November, 2014, and they were not initially familiar
10 with the prior proceedings in this case and the effect of the Will Contest case
11 intervention. In any event, the Court finds that the initial pleadings filed on behalf of
12 Jacqueline and Kathryn in these proceedings properly plead the claims for relief and
13 the defense that the Court has relied upon in granting Judgment to them in these
14 proceedings. Eleanor clearly had notice of the pleadings and in fact the parties
15 negotiated over all of the claims for relief and the affirmative defenses alleged by
16 Jacqueline and Kathryn in concerted settlement negotiations in October, 2014, and such
17 claims and defenses were contained in the several Petitions and Motions filed during
18 the proceedings. In particular the defense of laches was mentioned in the context of
19 equitable defenses mentioned in the initial pleading, and was the subject of a Motion
20 to Dismiss and resolve the case summarily both in late 2013 and in early 2014.
21 Accordingly, the Court finds that there is no reason to file an Amended Pleading in
22 these proceedings and Jacqueline and Kathryn's Motion seeking permission to file the
23 same is considered moot and resolved.

24 25. There are still some claims and issues that the Court is not resolving at this
25 time. Eleanor filed a counterclaim for wrongful interference with contract with her
26 Answer and Counterclaim filed herein on February 10, 2014. The Court finds that this
27 Counterclaim should be dismissed without prejudice at this time, since the issues
28 therein were not addressed by the Court in the January 30, 2015, hearing, but it seems

1 that the issues would be resolved with its decision herein on the Countermotions.
2 Nevertheless, if Eleanor believes she has a valid claim still against Jacqueline for
3 wrongful interference with contract, as asserted in her Answer and Counterclaim, she
4 is free to reassert the same.

5 26. Each of the parties asserted a claim against the other in these proceedings
6 seeking to have the Court enforce the no-contest clause contained in the Trust against
7 the other party. The Court finds that the positions of each of the parties, seeking the
8 correct interpretation of the Trust provisions as to entitlement to the Texas oil property,
9 were not asserted in bad faith, and that therefore good cause to impose the no-contest
10 penalties does not exist and such claims are denied with respect to both parties, Eleanor
11 on the one hand, and Jacqueline and Kathryn on the other hand.

12 27. There still remains the issues and concerns of who will serve hereafter as
13 the Trustee of the Trust, and whether or not the interests of subtrust 2 and subtrust 3
14 in the Texas oil property should now be formally split and allocated with deeds from
15 the main Trust to the subtrusts, so the parties can go their separate ways in dealing with
16 their interests in the Texas oil properties, subject to the terms of the Trust with respect
17 to subtrust 2. Clearly, under the Trust provisions, the beneficiaries under subtrust 3 are
18 granted the right to remove their interest in the Texas oil property out of the main Trust
19 and subtrust 3, to be owned independently by the MTC Living Trust and Jacqueline
20 and Kathryn as beneficiaries thereunder. However, the Court is directing the parties
21 to submit to the Court, on or before March 2, 2015, information regarding the
22 feasibility and effect of now splitting the Texas oil property between subtrust 2 and
23 subtrust 3 (or the MTC Living Trust), and whether or not such division of interests
24 could adversely affect the value and future ownership of the interests hereafter. The
25 Court will set a hearing to consider this issue on March 20, 2015, at 10:00a.m.

26 28. With respect to whether or not Eleanor should be able to continue serving
27 as Trustee, to address both Jacqueline's and Kathryn's position that she should be
28 removed for breach of her duties as Trustee, and Eleanor's position that she is not

1 disqualified from serving, the Court also is directing the parties to provide a brief in
2 support of their positions, filed on or before March 2, 2015, with the issue to then be
3 addressed by the Court at the hearing on March 20, 2015.

4 29. Lastly, with respect to the claim Jacqueline and Kathryn have made for an
5 award of attorney's fees against Eleanor, the Court is directing that the parties file with
6 their briefs due on or before March 2, 2015, their argument and basis for their positions
7 on the award of attorney's fees and costs against Eleanor for the Court to then resolve
8 at the hearing on March 20, 2015.

9 30. In addition to the matters addressed at the hearing on January 30, 2015,
10 there is a pending appeal to the Nevada Supreme Court, assigned Case No. 66231, filed
11 by Eleanor, appealing a portion of the Court's Order in these proceedings entered on
12 July 7, 2014. With the resolution of issues in this case as herein provided, the matter
13 on appeal is now rendered moot. Therefore, the parties should submit a stipulation to
14 the Nevada Supreme Court dismissing that appeal.

15 JUGMENT

16 Pursuant to NRCP Rule 56, the Court finds that the pleadings and other
17 documents filed herein, together with the affidavits and documentary evidence
18 presented, show there is no genuine issue as to any material fact and that Jacqueline
19 and Kathryn are entitled to judgment against Eleanor as a matter of law in these
20 proceedings. Therefore, and based upon the foregoing findings, good cause exists to
21 now render judgment against Eleanor, in favor of Jacqueline and Kathryn, as follows:

22 A. Jacqueline's and Kathryn's Countermotion for Summary Judgment is
23 granted in part as hereinafter provided. The Court hereby declares, adjudges and
24 determines that the allocation of interests in the Texas oil property between subtrust 2
25 and subtrust 3, under the W.N. Connell and Marjorie T. Connell Living Trust, dated
26 May 18, 1972, was properly made under the Trust provisions, with subtrust 2 receiving
27 a 35.507% interest in the Texas oil property and subtrust 3 receiving a 64.493%
28 interest in the Texas oil property.

1 B. The Court adjudges and determines that even if the allocation of the Texas
2 oil property made following the death of William in 1979, in conjunction with the
3 filing of his Federal and Texas Estate Tax Returns, was not properly or accurately made
4 between the two subtrusts, Eleanor's claim and effort to now challenge the allocation
5 and assert an interest greater than 35.507% in the Texas oil property being in subtrust
6 2, is too late and barred under the doctrine of laches, thereby making the actual division
7 made final and binding upon her.

8 C. Eleanor's Countermotion for Summary Judgment is hereby denied.

9 D. On or before March 2, 2015, Eleanor shall provide to Jacqueline and
10 Kathryn an accounting of the Texas oil property income received by the Trust from
11 January 1, 2012, through the entry of this Summary Judgment, showing the total
12 income received, expenses incurred, and any distributions made of the income. Within
13 30 days following the entry of this Summary Judgment, Eleanor shall reimburse and
14 pay to Jacqueline and Kathryn any portion of their 65% share of the Texas oil property
15 income which was not distributed to them during this period of time. From and after
16 the entry of this Summary Judgment, 35% of the Texas oil property income shall be
17 distributed to Eleanor as beneficiary under subtrust 2, and 65% of the income shall be
18 distributed equally between Jacqueline and Kathryn as beneficiaries under subtrust 3
19 and the MTC Living Trust.

20 E. Eleanor's Counterclaim for wrongful interference with contract asserted
21 with her Answer and Counterclaim filed herein on February 10, 2014, is hereby
22 dismissed without prejudice.

23 F. The Court adjudges and determines that the positions of each of the
24 parties, seeking the correct interpretation of the Trust provisions as to entitlement to
25 the Texas oil property, were not asserted in bad faith, and that therefore good cause to
26 impose the no-contest penalties does not exist and such claims, both Eleanor's claim
27 on the one hand, and Jacqueline's and Kathryn's claim on the other hand, are denied
28 with prejudice.

1 G. Each of the parties is directed to file further briefing on the following
2 issues with the Court on or before March 2, 2015, which issues and matters will be
3 resolved by the Court at the next hearing in these proceedings, hereby set on March 20,
4 2015, at 10:00a.m.:

5 1) In the event there is no formal splitting of the Texas oil property between
6 subtrust 2 and subtrust 3 at this time, is there cause to remove Eleanor as Trustee and
7 appoint Jacqueline as the successor Trustee of the Trust and the subtrusts thereunder?
8 If cause does not exist for Eleanor's removal, would it still be better to appoint a
9 neutral successor Trustee?

10 2) Should the interests of subtrust 2 and subtrust 3 in the Texas oil property
11 now be formally split and allocated with deeds from the main Trust to the subtrusts, so
12 the parties can go their separate ways in dealing with their interests in the Texas oil
13 properties, subject to the terms of the Trust with respect to subtrust 2? The Court wants
14 the parties to provide recommendations from qualified persons knowledgeable with
15 respect to the Texas oil and mineral rights and the potential harm or benefit that could
16 result in a splitting of the interests between the parties, and whether or not such
17 division of interests could adversely affect the value and future ownership of the
18 interests hereafter.

19 3) Lastly, with respect to the claim Jacqueline and Kathryn have made for an
20 award of attorney's fees against Eleanor, the Court directs the parties to provide their
21 argument and basis for their positions on the award of attorney's fees and costs against
22 Eleanor in briefing filed on or before March 2, 2015, for the Court to then resolve at
23 the scheduled hearing on March 20, 2015.

24 H. The parties shall each sign a Stipulation and Order for Dismissal of the
25 Appeal presently pending in Nevada Supreme Court Case No. 66231, filed by Eleanor,
26 appealing a portion of the Court's Order in these proceedings entered on July 7, 2014.

27 I. The Court retains jurisdiction over the Trust pending the finalization and
28 resolution of the remaining issues mentioned above, to be addressed hereafter at the

1 hearing scheduled on March 20, 2015, at 10:00a.m. Until that date, Eleanor shall
2 continue to exercise and fulfill her duties as Trustee of the Trust, and the parties shall
3 all cooperate, in the best interest of the Trust and its beneficiaries, in any dealings with
4 the oil companies affecting the Texas oil property.



**ORDER REGARDING THE ACCOUNTING, BREACH OF FIDUCIARY DUTY

This matter, having come before the Honorable Gloria Sturman on March 20, 2015, 2015 for summary judgment, Whitney B. Warnick, Esq. of the law firm Albright Stoddard, Warnick & Albright appearing on behalf of Kathryn A. Bouvier, Joseph J. Powell, Esq. of the Rushforth Firm, Ltd. appearing on behalf of Jacqueline M. Montoya, and Dale A. Hayes, Esq. and Liane K. Wakayama, Esq. of the law firm Marquis Aurbach Coffing appearing on behalf of Eleanor Connell Hartman Ahern, as Trustee of The W.N. Connell and Marjorie T. Connell Living Trust dated May 18, 1972, the Court having considered the Brief Regarding Pending Issues; the Brief Regarding Accounting, Fiduciary Duties, and Trust Administration; the Supplement to Brief Regarding Pending Issues; the Supplement to Brief Regarding Accounting, Fiduciary Duties, and Trust Administration; the Second Supplement to Brief Regarding Pending Issues, and the underlying papers and pleadings, as well as the oral arguments of counsel, and good cause appearing therefore, the Court FINDS and ORDERS as follows:

1 1. At a hearing held on January 30, 2015, the Court ordered that Eleanor Connell

12 Accountants, Gamett and King, for the time period of June 2013 through January 2015 (the

15 fees are approved. The Court finds the Trustee fees unreasonable and not supported in any way.

18 out the Trustee's Fee from the Accounting as an unapproved expense; however, Eleanor may be

20 6. The \$37,000 distribution to Jacqueline and Kathryn in June 2013 was for income
21 earned and received by the Trust prior to June 2013. The Court therefore finds that the \$37,000
22 distribution should not be included in the Accounting as a credit to the 65% share that is to be
23 held in trust for the benefit of Jacqueline and Kathryn.

24 7. Based on removing the \$218,760.17 in Trustee fees and not crediting the \$37,000
25 distribution, the Court finds that a total of \$2,163,758.88 shall be held in trust for the benefit of
26 Jacqueline and Kathryn, which represents their 65% share of the total net income received by the
27 Trust from June 1, 2013 through January 31, 2015.

1 8. The \$500,000 on deposit with Fidelity Capital Inc. ("Fidelity Capital") is not a
2 prudent investment. *NRS 164.640 et seq.*

3 9. Aside from the \$218,760.17 Trustee fees, the \$37,000 distribution and the
4 \$500,000 on deposit with Fidelity Capital, the Accounting is approved.

5 **Cutting Off the 65% Income**

6 10. As Trustee of the Trust, Eleanor owed fiduciary duties to Jacqueline and Kathryn
7 as beneficiaries of the Trust.

8 11. In June 2013, Eleanor cut off the 65% income stream of the net oil revenue in her
9 capacity as Trustee of the Trust, *without first seeking instruction from*
10 *the Court.*

11 **CONCLUSIONS OF LAW**

12 12. Pursuant to Nev. R. Civ. P. 56(b), "[a] party against whom a claim, counterclaim,
13 or cross-claim is asserted or a declaratory judgment is sought may, at any time, move with or
14 without supporting affidavits for a summary judgment in the party's favor as to all or any part
15 thereof." "The judgment sought shall be rendered forthwith if the pleadings . . . show that there
16 is no genuine issue as to any material fact that the moving party is entitled to judgment as a
17 matter of law." NRCP 56(c). The burden for demonstrating the absence of a genuine issue of
18 material fact lies with the moving party, and the material lodged by the moving party must be
19 viewed in the light most favorable to the non-moving party. Hoopes v. Hammargren, 102 Nev.
20 425, 429, 725 P.2d 238, 241 (1986). It is well settled in Nevada that the party opposing
21 summary judgment is entitled to all favorable inferences from the pleadings and documentary
22 evidence. See Mullis v. Nev. Nat'l Bank, 98 Nev. 510, 512, 654 P.2d 533, 535 (1982). The non-
23 moving party, however, "must, by affidavit or otherwise, set forth specific facts demonstrating
24 the existence of a genuine issue for trial or have summary judgment entered against him."
Bulbman, Inc. v. Nev. Bell, 108 Nev. 105, 110, 825 P.2d 588, 591 (1992).

25 13. To prevail on a breach of fiduciary duty claim in Nevada, Jacqueline and Kathryn
26 bear the burden of showing that: (1) Eleanor owed them a fiduciary duty; (2) Eleanor breached
27 that duty; and (3) Jacqueline and Kathryn sustained damages as a proximate cause of the breach.
28 See Mosier v. S. Cal. Physicians Ins. Exch., 74 Cal.Rptr.2d 550, 565 (Cal. Ct. App. 1998).

1 14. The Court concludes as a matter of law that Eleanor did not breach any fiduciary
2 duties as it relates to the Accounting.

3 15. The Court concludes as a matter of law that Eleanor breached her fiduciary duties
4 owed to Jacqueline and Kathryn by failing to retain a third-party trustee and petition the Court to
5 allow the 65% income stream to Jacqueline and Kathryn to be cut off. As a result of Eleanor's
6 breach of fiduciary duties, Eleanor shall be removed as Trustee only over the 65% share of the
7 Upton County, Texas oil assets. Eleanor shall remain as Trustee over her 35% share of the
8 Upton County, Texas oil assets; however, a temporary successor Trustee shall be appointed over
9 the entire Trust until this litigation is finally resolved.

10 16. Based on Eleanor breaching her fiduciary duties, the Court will award Jacqueline
11 and Kathryn their attorney fees and costs pursuant to NRS 153.031(3)(b). The Court reserves for
12 a later date the exact amount of attorney fees and costs to be awarded.

13 BASED ON THE FOREGOING, IT IS HEREBY ORDERED, ADJUDGED AND
14 DECREED that:

15 1. The \$500,000 currently on deposit with Fidelity Capital shall be deposited into an
16 FDIC insured bank account;

17 2. Jacqueline and Kathryn's claim for breach of fiduciary duty against Eleanor, as
18 Trustee of the Trust, is DENIED as it relates to the Accounting *based on the information*
available to the Court on March 20, 2015;

19 3. Summary judgment on Jacqueline and Kathryn's claim for breach of fiduciary
20 duty against Eleanor, as Trustee of the Trust, is GRANTED as it relates to Eleanor cutting of
21 their 65% distributions of the oil income in June 2013;

4. Golden Gate Nat'l Bank, 85 Nev. 345, 455 P.2d 31 (1969) as well as their redacted billing statements. The deadlines for the briefing schedule shall comply with E.D.C.R. 2.20. The hearing on the Application shall be set for May 13, 2015 at 9:00 a.m.

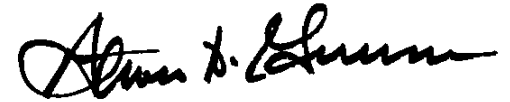

7 as beneficiaries of the Trust.

8 11. In June 2013, Eleanor cut off the 65% income stream of the net oil revenue in her
9 capacity as Trustee of the Trust, *without first seeking instruction from*
10 *the Court.*

11 CONCLUSIONS OF LAW

12 12. Pursuant to Nev. R. Civ. P. 56(b), "[a] party against whom a claim, counterclaim,
13 or cross-claim is asserted or a declaratory judgment is sought may, at any time, move with or
14 without supporting affidavits for a summary judgment in the party's favor as to all or any part
15 thereof." "The judgment sought shall be rendered forthwith if the pleadings . . . show that there
16 is no genuine issue as to any material fact that the moving party is entitled to judgment as a
17 matter of law." NRCP 56(c). The burden for demonstrating the absence of a genuine issue of
18 material fact lies with the moving party, and the material lodged by the moving party must be
19 viewed in the light most favorable to the non-moving party. Hoopas v. Hammargren, 102 Nev.
20 425, 429, 725 P.2d 238, 241 (1986). It is well settled in Nevada that the party opposing
21 summary judgment is entitled to all favorable inferences from the pleadings and documentary
22 evidence. See Mullis v. Nev. Nat'l Bank, 98 Nev. 510, 512, 654 P.2d 533, 535 (1982). The non-
23 moving party, however, "must, by affidavit or otherwise, set forth specific facts demonstrating
24 the existence of a genuine issue for trial or have summary judgment entered against him."
Bulbman, Inc. v. Nev. Bell, 108 Nev. 105, 110, 825 P.2d 588, 591 (1992).

25 13. To prevail on a breach of fiduciary duty claim in Nevada, Jacqueline and Kathryn
26 bear the burden of showing that: (1) Eleanor owed them a fiduciary duty; (2) Eleanor breached
27 that duty; and (3) Jacqueline and Kathryn sustained damages as a proximate cause of the breach.
28 See Mosier v. S. Cal. Physicians Ins. Exch., 74 Cal.Rptr.2d 550, 565 (Cal. Ct. App. 1998).

1 14. The Court concludes as a matter of law that Eleanor did not breach any fiduciary
2 duties as it relates to the Accounting.

3 15. The Court concludes as a matter of law that Eleanor breached her fiduciary duties
4 owed to Jacqueline and Kathryn by failing to retain a third-party trustee and petition the Court to
5 allow the 65% income stream to Jacqueline and Kathryn to be cut off. As a result of Eleanor's
6 breach of fiduciary duties, Eleanor shall be removed as Trustee only over the 65% share of the
7 Upton County, Texas oil assets. Eleanor shall remain as Trustee over her 35% share of the
8 Upton County, Texas oil assets; however, a temporary successor Trustee shall be appointed over
9 the entire Trust until this litigation is finally resolved.

10 16. Based on Eleanor breaching her fiduciary duties, the Court will award Jacqueline
11 and Kathryn their attorney fees and costs pursuant to NRS 153.031(3)(b). The Court reserves for
12 a later date the exact amount of attorney fees and costs to be awarded.

13 BASED ON THE FOREGOING, IT IS HEREBY ORDERED, ADJUDGED AND
14 DECREED that:

15 1. The \$500,000 currently on deposit with Fidelity Capital shall be deposited into an
16 FDIC insured bank account;

17 2. Jacqueline and Kathryn's claim for breach of fiduciary duty against Eleanor, as
18 Trustee of the Trust, is DENIED as it relates to the Accounting *based on the information*
available to the Court on March 20, 2015;

19 3. Summary judgment on Jacqueline and Kathryn's claim for breach of fiduciary
20 duty against Eleanor, as Trustee of the Trust, is GRANTED as it relates to Eleanor cutting of
21 their 65% distributions of the oil income in June 2013;

4. Jacqueline and Kathryn shall submit an Application for their award of attorney fees and costs pursuant to NRS 153.031(3)(b), which shall include a proper analysis of the factors set forth in Brunzell v. Golden Gate Nat'l Bank, 85 Nev. 345, 455 P.2d 31 (1969) as well as their redacted billing statements. The deadlines for the briefing schedule shall comply with E.D.C.R. 2.20. The hearing on the Application shall be set for May 13, 2015 at 9:00 a.m.

MEMORANDUM OF POINTS AND AUTHORITIES

I. INTRODUCTION

There are two questions before the Court. First, what are the reasonable fees incurred by the Sisters in this litigation. Second, what percentage of these fees, if any, should be shifted to Ms. Ahern personally.

On the one hand, the Court has found that Ms. Ahern breached her fiduciary duty by failing to notify the Sisters of her intent to stop distributions of income from the trust in 2013, or to otherwise seek a declaration from the Court *prior to* suspending such payments. As the Court noted, "you can't just stop making payments," and as opposing counsel stated, payment "was unilaterally cut off...[and] *[t]hat's where this fiduciary breach lies.*" (Tr. of Proceeding dated Mar. 20, 2015 ["Transcript"], p. 49:11, 72:7 on file herein.) (Emphasis added.)

On the other hand, and notwithstanding Ms. Ahern's actions that *initiated* this dispute, the Court found—regarding the dispute itself—that "the position of both parties, seeking the correct interpretation of the Trust provisions as to entitlement to the Texas oil property, *were not asserted in bad faith.*" (Summ. J. dated Apr. 16, 2015 ["MSJ Order"], ¶¶ 26, F, on file herein.) The Court also granted Ms. Ahern leave to refile her counterclaims in another action. (*Id.* at ¶ 25, E.) In other words, the beneficiaries of the trust had a good faith, positional disagreement over the entitlements.

Now the Court is asked to order an award of attorneys' fees against Ms. Ahern personally in the amount of \$417,855.56, "if the court determines that such additional relief is *appropriate to redress or avoid an injustice.*" NRS 153.031(3)(b). While the manner in which Ms. Ahern initiated this controversy—by "unilaterally" stopping payments to the Sisters—may have been a breach of duty, that breach was not the *cause* of the dispute between the beneficiaries or the majority of attorneys' fees incurred herein. The Court has already recognized that

1 the true purpose of this declaratory action is resolution of a good faith dispute
2 between beneficiaries over the "correct interpretation of the Trust provisions." (MSJ
3 Order at ¶¶ 26, F.) Even if Ms. Ahern, as Trustee, had implemented better
4 procedures initially (*e.g.* formally notified the Sisters prior to discontinuing
5 payments), the parties—whose positions were and are adamantly opposed to each
6 other—would likely have found themselves in this very Court incurring these very
7 fees now requested. Because prosecuting and/or defending good faith claims is not
8 a breach of fiduciary duty, nor is it an "injustice" that must be "redressed," an award
9 of attorneys' fees against Ms. Ahern *personally* under NRS 153.031(3)(b) in this
10 case is unwarranted.

11 If an award of attorneys' fees is granted, the Court should certainly not grant
12 the Sisters' unreasonable request for \$417,855.56, nor assign any portion of that
13 amount to Ms. Ahern personally. Part of the fees requested are duplicative and
14 prohibited by virtue of a stipulation signed in a separate litigation. Moreover, the
15 Sisters have not provided the appropriate documentation to satisfy the factors
16 articulated in *Brunzell*. In the absence of the such evidence, the Court cannot
17 properly award a reasonable fee.

18 **II.**
19 **DOCUMENTATION PROVIDED IN SUPPORT OF ATTORNEYS' FEES**

20 The Sisters each retained separate counsel in this case, except as to their joint
21 defense against Ms. Ahern's counterclaims. (*See* Mot. at Ex. A, p. 1.) Ms. Montoya
22 retained The Rushforth Firm, Ltd. ("Rushforth") and Ms. Bouvier retained the law
23 firm of Albright Stoddard, Warnick & Albright ("Albright") (collectively, "Sisters'
24 Counsel").

25 Rushforth and Albright filed a joint Motion in Support of Attorneys' Fees and
26 Costs, and provided the following information in support:

27 Exhibit A – Index of all pleadings filed in this action;
28

11 Exhibit D³ – Southwest Airlines tickets purchased to attend the February 18,
12 2014, evidentiary hearing.

Based on the information provided by in the application, and as discussed further herein, the Sisters' request for attorneys' fees should be rejected or reduced appropriately.

18 In Nevada, courts follow the American Rule, which is the legal presumption
19 that each party bears its own attorneys' fees incurred in litigation. *See Bobby*
20 *Berosini, Ltd. v. PETA*, 114 Nev. 1348, 1356, 971 P.2d 383, 388 (1998);
21 *Consumers League v. Southwest Gas*, 94 Nev. 153, 156, 576 P.2d 737, 738 (1978).

¹ In the Motion, the Sisters state that "the Docket Sheet [is] attached hereto as Exhibit B." (Mot. at p. 4:25.) However, Exhibit B to the Motion contains numerous other documents, as detailed in this paragraph. Because the documents are not properly organized, Ms. Ahern will make best efforts in this Opposition to direct the Court to the appropriate source.

26 Although the Albright/Powell Declaration contains an Exhibit C, there is no Exhibit C to the Motion/Application itself.

Exhibits B, C, and D are identified in Paragraphs 10, 11, and 12 of the
Rushforth Declaration. Paragraph 10 and 11 state that Exhibits B and C are
"[a]ttached to the *Declaration*," whereas Paragraph 12 states that Exhibit is
"[a]ttached to the *Application* [for attorneys' fees]."

1 However, there are limited exceptions to the American Rule. *Id.* Here, the Court
2 may award fees pursuant to NRS 153.031(3)(b).⁴ In doing so, it must find that
3 "such additional relief is appropriate to redress or avoid an injustice." NRS
4 153.031(3).

5 In Nevada, "the method upon which a reasonable fee is determined is subject
6 to the discretion of the court" which "is tempered only by reason and fairness."
7 *Shuette v. Beazer Homes Holdings Corp.*, 121 Nev. 837, 864, 124 P.3d 530, 548
8 (2005). In exercising this discretion, the Court is guided by the factors set forth in
9 *Brunzell v. Golden Gate Nat. Bank*, 85 Nev. 345, 349, 455 P.2d 31, 33 (1969). These
10 factors are: (1) the advocate's professional qualities; (2) the nature of the litigation;
11 (3) the work performed; and (4) the result.

12 As a preliminary matter, a fee award against Ms. Ahern personally is unjust
13 because her breach is not the cause of this litigation. As the Court found, the cause
14 of this litigation is a good faith dispute between Ms. Ahern and the Sisters
15 regarding their respective rights to distributions from the relevant trusts. In
16 addition, even if the Sisters are correct in their claim for attorneys' fees, the ultimate
17 award, which must be reasonable in light of the circumstances, must be reduced for
18 the following reasons: (1) recognition that the breach itself was not the cause of the
19

20 ⁴ In relevant part, NRS 153.031(3)(b) states as follows:

21 If the court grants any relief to the petitioner, the court
22 may, **in its discretion**, order any or all of the following
23 additional relief if the court determines that **such**
24 **additional relief is appropriate to redress or avoid an**
25 **injustice:**

26 (b) Order the trustee to pay to the petitioner or any other
27 party all **reasonable costs** incurred by the party to
28 adjudicate the affairs of the trust pursuant to this section,
including, without limitation, reasonable attorney's fees.
Except as otherwise provided in NRS 165.139, **the**
trustee may not be held personally liable for the
payment of such costs unless the court determines that
the trustee...breached his or her fiduciary duties.

1 fees incurred in this dispute; (2) the Sisters fail to provide evidence supporting the
2 factors articulated in *Brunzell*; and (3) the Sisters seek double-recovery for fees
3 incurred in connection with the Will Contest Litigation. NRS 153.031(3).

4 **A. Because The Breach of Fiduciary Duty Is Not The Cause In Fact Of The**
5 **Fees Incurred In This Action, An Award Of Attorneys' Fees Against Ms.**
6 **Ahern, Personally, Is Unjust.**

7 It must be recognized that, once the parties moved past the initial breach of
8 duty, *see* Introduction, *supra*, Ms. Ahern's role in this litigation was as much if not
9 more so as a beneficiary than as a trustee. Certainly the trustee would not be liable
10 for attorneys' fees for a dispute between beneficiaries over the interpretation of the
11 trust documents. This is important in that the shifting of fees to Ms. Ahern
12 personally begins with recognition that any fee award is appropriate "to redress or
13 avoid an injustice," which invokes the Court's equity power and its discretion.⁵
14 NRS 153.031(3).

15 As discussed in the introduction, *supra*, the Court has already determined
16 that this is a good faith dispute between the parties. Had Ms. Ahern initiated a
17 declaratory relief action rather than withheld the funds without notice, the parties
18 would likely have incurred the same fees as are requested by the Sisters in this
19 Motion. The Sisters are not the only parties to this litigation that incurred fees and
20 costs. A shifting of the Sisters' fees to Ms. Ahern, personally, does not redress or
21 avoid an injustice; rather, it creates an injustice.

22 Ms. Ahern should be personally liable, if at all, only for the payment of fees
23 and costs caused by an actual breach of duty, and not the aggregate amount of the
24 fees and costs incurred in this litigation.⁶ *See* NRS 153.031(3)(b). No award can be

25 ⁵ A plain reading of the statute indicates that this discretion is broad, and
26 does not require that all fees awarded to the Sisters be shifted to Ms. Ahern
27 personally, particularly in case such as this where Ms. Ahern has litigated as both a
28 trustee and a beneficiary. The inquiry into whether Ms. Ahern breached her duty is
separate from the inquiry into the appropriate liability for attorneys' fees. **Nowhere
does the statute require that the Court shift all fees awarded.**

⁶ These fees and costs include at most any amounts relating to the Sisters'
Petitions to compel Ms. Ahern to distribute funds and/or the briefing on the issue of

1 "just" if the cause of the fees is unrelated to the breach of duty by the trustee.
2 Indeed, precedence dictates that courts should exercise restraint when awarding
3 costs and fees pursuant to a statute, in light of the fact that statutes permitting
4 recovery are in derogation of the common law and must be strictly construed. *See*
5 *Bergmann v. Boyce*, 109 Nev. 670, 679, 856 P.2d 560, 566 (1993).

6 In the March 20, 2015, hearing before this Court, without even being pressed
7 on the issue, counsel for the Sisters agreed that some \$390,000 of their total fee
8 request was not incurred as part of their breach of fiduciary duty claim; rather, most
9 of the fees and costs incurred were due to the disagreement between beneficiaries
10 over the ownership of the trust (this is a disagreement in which the trustee
11 ultimately has no stake). (*See* Transcript at pp. 54:23-55:11.) In fact, both attorneys
12 for the Sisters, Ms. Warnick and Mr. Powell, admitted in open court that the fees
13 being sought were not just for the breach of fiduciary duty claim, but for the whole
14 trust litigation. (*Id.*)

15 More specifically, Mr. Warnick confesses that "[their] fees [were] for the
16 whole...trust case." (*Id.* at p. 55:7-9.) Mr. Powell claims that there was "no
17 dispute" that most of the fees incurred were not in relation to the Sisters' breach of
18 duty claim, but for the whole trust litigation. (*Id.* at p. 55:8.) As such, while fees
19 may be awarded in this instance, the Sisters are not allowed to hold Ms. Ahern
20 personally liable for all the fees and costs incurred in this matter. Instead, pursuant
21
22

23 breach of fiduciary duty. (*See, e.g.*, Sisters' Petition filed Dec. 3, 2013, on file
24 herein.) The statutory basis for shifting fees in this particular matter—NRS
25 153.031(3)(b)—permits the Sisters to recover fees incurred to bring their claim for
26 breach of fiduciary duty, but does not permit recovery of fees incurred for ancillary
27 issues, such as litigation between beneficiaries or the Sisters' defense against Ms.
28 Ahern's counterclaims. The fees incurred in the Sisters' failed attempts to dismiss
Ms. Ahern's counterclaims (which the Court found were brought in good faith), for
example, should be excluded from the ultimate award bestowed upon the Sisters
and/or not shifted to Ms. Ahern personally.

1 to NRS 153.031(3)(b) and the discretion of this Court, they can only recover the
2 fees they expended as a result of the claimed breach of fiduciary duty.

3 As discussed in the introduction, Ms. Ahern's breach was the manner in
4 which she stopped payments. Yet, it was not the manner in which she stopped
5 payment or any other execution of her duties as trustee that caused this positional
6 disagreement between beneficiaries of the trust. The actual cause of this
7 proceeding—a good faith dispute over the Trust provisions as to entitlement to the
8 Texas oil property—is not the sort of breach (or a breach at all) as contemplated
9 under NRS 153.031(3)(b), for which the trustee should be held personally liable.
10 As such, this Court should reduce any fee award against Ms. Ahern personally to
11 reflect the circumstances of this case and the intent of NRS 153.031(2)(b).

12 **B. The Sisters Fail To Provide Sufficient Evidence In Support Of The**
13 **Factors Articulated In *Brunzell*.**

14 This Court should also reduce any fee award given to Plaintiff because the
15 amount of fees sought are unreasonable in light of the *Brunzell* factors. In Nevada,
16 district courts enjoy great discretion when awarding attorney fees. *Shuette v.*
17 *Beazer Homes Holdings Corp.*, 121 Nev. 837, 864, 124 P.3d 530, 548–49 (2005).
18 When determining a fee award, the court is not bound to one specific approach; but
19 instead, the court may employ “any method rationally designed to calculate a
20 reasonable amount, so long as the requested amount is reviewed in light of the
21 *Brunzell* factors.” *Haley v. Dist. Ct.*, 128 Nev. Adv. Op. 16, 273 P.3d 855, 860
22 (2012) (citing *Brunzell v. Golden Gate National Bank*, 85 Nev. 345, 349, 455 P.2d
23 31, 33 (1969)).

24 Notably, in *Brunzell*, the Court articulated four factors courts should consider
25 when determining the reasonable value of an attorney’s services: (1) the qualities of
26 the advocate, including the attorney’s ability, training, education, experience,
27 professional standing and skill; (2) the character of the work to be done: its
28 difficulty, its intricacy, its importance, time and skill required, the responsibility

1 imposed and the prominence and character of the parties where they affect the
2 importance of the litigation; (3) the work actually performed by the lawyer: the
3 skill, time and attention given to the work; and (4) the ultimate result—whether the
4 attorney was successful and what benefits were derived. *Brunzell*, 85 Nev. at 349,
5 455 P.2d at 33.

6 1. ***First Factor: the qualities of the advocate, including the attorney's***
7 ***ability, training, education, experience, professional standing and***
8 ***skill.***

9 a. Albright

10 Albright provided the following information regarding the first factor:
11 Whitney Warnick, Esq., who billed 455 hours on this matter at a rate of \$300 per
12 hour, has been practicing for 36 years, including work on "complicated trials and
13 appeals," with an "emphasis in the area of Estates and Trusts and litigation."
(Albright/Warnick Dec. at ¶ 4.).

14 In addition, we know that the other four Albright attorneys that worked on
15 this case have "extensive experience in Court litigation." (*Id.* at ¶ 5.). *Nothing*
16 *more.* In sum the Motion, which was filed specifically for the purpose of
17 supporting the Sisters'/Albright's request for nearly \$130,000 in attorneys' fees,
18 provides little support for an award under the first *Brunzell* factor.

19 b. Rushforth

20 Rushforth provided the following information regarding the first factor:
21 Joseph Powell, Esq., who billed 782.8 hours on this matter at a rate of \$350, has
22 been practicing for 11 years. (*See* Rushforth/Powell Dec. at ¶ 1.) In addition,
23 Kennedy Lee, Esq. and Layne, Rushforth, Esq., have been practicing for 3 and 34
24 years, respectively. (*Id.* at ¶ 4.). Their years of practice were provided, but *nothing*
25 *more.*

26 While the Rushforth/Powell Declaration contains Mr. Powell's belief that
27 "expertise in the area of Trusts and Estates, litigation, and appellate work, was
28 required to properly represent Ms. Montoya," no support is provided for any of the

1 Rushforth attorneys' training, education, or experience with regard to any of those
2 items. (*Id.* at p. 17).

3 In fact, the unexplained difference in time spent on this case between Ms.
4 Warnick and Mr. Powell is disconcerting. Ms. Warnick, with 36 years of
5 experience with trusts and estates, required **455** hours to complete her work on
6 behalf of Ms. Bouvier (*and* Ms. Montoya at times), and billed at a lower rate
7 (\$300). Mr. Powell, on the other hand, with only 11 years of experience (number of
8 years working with trusts and estates is not provided) spent **782.8** hours to complete
9 his work on behalf of Ms. Montoya only, and billed at a higher rate (\$350). This
10 juxtaposition of the Albright and Rushforth declarations raises serious concerns
11 about the fairness and reasonableness of the Sisters' fee requests (*e.g.* a younger,
12 less experienced lawyer spends twice as much time and bills at a higher rate). This
13 concern is only compounded by the fact that the Motion, which was filed
14 specifically for the purpose of supporting the Sisters'/Rushforth's request for nearly
15 \$290,000 in attorneys' fees, provides little to no support for an award under the first
16 *Brunzell* factor, other than the amount of time each attorney has been practicing.

17 **2. Third Factor: Work Actually Performed by the Lawyer**

18 Unnecessary work must be eliminated from any potential fee award.
19 “[H]ours that are not properly billed to one’s client also are not properly billed to
20 one’s adversary pursuant to statutory authority.” *Ass’n of California Water Agencies*
21 *v. Evans*, 386 F.3d 879, 887 (9th Cir. 2004) (internal quotations omitted); *see also*
22 *National Ass’n of Concerned Veterans v. Secretary of Defense*, 675 F.2d 1319,
23 1327–28 (D.C.Cir.1982) (find that “fees are not recoverable for nonproductive
24 time”).

25 The discussion under the first factor, *supra*, regarding the disparity between
26 work performed by Mr. Powell and Ms. Warnick is relevant here. Mr. Powell has
27 much less experience but charged a higher rate than Ms. Warnick. Mr. Powell
28 required several hundred additional hours to complete the work. Mr. Powell also

1 required an additional 164 hours or ~\$40,000 worth of work from other attorneys or
2 paralegals at his firm, whereas Ms. Warnick required only 57.5 hours or ~\$19,000
3 worth of work from other attorneys at her firm. If there is an explanation for this
4 discrepancy in work that actually needed to be performed, it is not evident within
5 the Sisters' application for attorneys' fees.

6 **C. The Fees Sought For Work Completed In Relation To The Will Contest**
7 **Litigation Should Be Denied.**

8 Here, while the *Brunzell* factors are relevant to the Court's determination of
9 the reasonableness of any fees given to Plaintiff, the Court should also consider
10 some of the billing irregularities in the documentation provided by the Sisters. Ms.
11 Warnick admits in her declaration that the "billing statement may be a bit
12 confusing." (Albright/Warnick Dec. at ¶ 6.) Importantly, and as mentioned above,
13 this Court should not allow the Sisters to recover any fees pursuant to the Will
14 Contest Litigation, Case No. P-14-080595-E.

15 In the Will Contest Litigation, upon stipulation, Ms. Ahern paid \$75,000 to
16 the Sisters for legal fees incurred therein, and the Sisters waived "any and all
17 rights...to seek the recovery of any additional legal expenses incurred *in relation to*
18 *the Will Contest.*" (See Stip. and Order for Dismissal With Prejudice dated Jan. 9,
19 2015 [the "Fee Stipulation"], attached as Exhibit A.) Despite the fact that the
20 Sisters have already recovered such fees for work done "in relation to the Will
21 Contest," the Sisters now seek an additional 50% payment for such work, arguing
22 that the work was also used in this litigation. Simply because the work was used
23 for two purposes does not mean that the Sisters are entitled to a windfall recovery in
24 violation of the Fee Stipulation. Ms. Ahern already agreed to pay \$75,000 in
25 satisfaction of any attorneys' fees related to the Will Contest. If that number only
26 represented 50% of the work, it is too late, and the Sisters cannot attempt to recover
27 the other 50% through this Motion in violation of the stipulation.

1 The declarations attempt briefly to account for such fees. Ms. Warnick
2 essentially states that it was too difficult to discern which fees were incurred for
3 each of the two cases from May through December of 2014, and thus Albright
4 simply split its fees in half, for a total of \$33,000. (Albright/Warnick Dec. at ¶¶ 7-
5 8.) Mr. Powell, on the other hand, simply apportions \$42,000 to the Will Contest
6 litigation and makes no attempt to explain or account for any work that was
7 beneficial to and/or used in both cases. (Rushforth/Powell Dec. at ¶ 13.) And in
8 what amounts to an admission of double recovery, Ms. Warnick states that "the
9 same services [were] sometimes being relevant for the benefit of both cases." (*Id.*)

10 The Sisters already duplicated their fees by hiring separate counsel to
11 advocate essentially the same positions. Another duplication should not be
12 permitted, as it would amount to yet another penalty to Ms. Ahern for litigating her
13 claims in good faith and for negotiating an acceptable disposition (through
14 stipulation) of the Will Contest Litigation. The assessment of these fees are
15 unreasonable, and the stipulation precludes recovery of at least \$75,000 requested
16 by the Sisters (in addition to the \$75,000 they have already voluntarily removed).⁷

17 **IV.** 18 **CONCLUSION**

19 NRS 153.031(3) invokes the Court's equity power to award reasonable fees
20 in order ensure a just outcome. The Court should recognize Ms. Ahern's dual role
21 in this litigation and that she is not the intended wrongdoer under NRS
22 153.031(3)(b). Her prior breach of duty was not cause of the fees incurred in this
23 good faith, positional disagreement between the beneficiaries and should not give
24 rise to a shift of attorneys' fees to her personally. Even if some fees are awarded,

25
26 ⁷ Rushforth reduced its fees by \$42,000, and Albright reduced its fees by
27 \$33,000, presumably to match the \$75,000 described in the stipulation and already
28 paid by Ms. Ahern. Because they have represented that \$75,000 equates to 50% of
the work done during the applicable time period, it reasons that another \$75,000 has
been improperly included in this fee request. The Sisters' rights to such overlapping
fees were waived in the stipulation.

1 the amount should be reduced to include only those activities, if any, that are
2 directly caused by Ms. Ahern's breach. Finally, the Court should consider the
3 deficiencies in the Sisters' application for attorneys' fees, find that it is not possible
4 to make a reasonable estimation of appropriate costs and, based on the reasons
5 expressed herein, deny the Sisters request.





MOTION IN SUPPORT OF AWARD OF ATTORNEY'S FEES AND COSTS

In the hearing in this case on March 20, 2015, the Court granted the request of Jacqueline M. Montoya ("Jacqueline") and Kathryn A. Bouvier ("Kathryn") for an award of attorney's fees and costs against Eleanor Connell Hartman Ahern. Counsel for Jacqueline and Kathryn were directed to submit their redacted billing statements, and the information for the Court to consider in making an award, required in *Brunzell v. Golden Gate National Bank*, 85 Nev. 345, 455 P.2d 31 (1969). Attached hereto are the Declarations of Whitney B. Warnick, Esq., and Joseph J. Powell, Esq., which along with the following analysis provide the necessary information.

RELEVANT CASE HISTORY

This proceeding started with the filing of a Petition for Declaratory Judgment on September 27, 2013, by Jacqueline M. Montoya (“Jacqueline”), as Trustee of the MTC Living Trust, dated December 6, 1995, on her own behalf and that of her sister, Kathryn A. Bouvier (“Kathryn”), as beneficiaries under the MTC Living Trust. As beneficiaries under said Trust, they had for several years been receiving 65% of the income from the W. N. Connell and Marjorie T. Connell Living Trust, dated May 19, 1972 (“Trust”). However, in approximately June, 2013, Eleanor Connell Hartman Ahern (“Eleanor”), as Trustee of the Trust, abruptly stopped income payments to them, necessitating the filing of their Petition for Declaratory Judgment.

Litigation has continued in this proceeding since the filing of said Petition to the present day. Attached hereto as Exhibit “A” is a list of the various Petitions, Motions, Responses, Objections and other pleadings filed through January 12, 2015. Since January 12, 2015, there have been four additional hearings before the Court requiring the preparation and filing of additional Motions, Oppositions and other various documents with the Court, as noted in the copy of the Docket Sheet attached hereto as Exhibit “B”.

In addition to the proceedings before this Court, counsel for Jacqueline and Kathryn were required to represent their clients in an appeal to the Nevada Supreme Court filed by Eleanor, appealing a decision of the Court in its Order entered herein on May 13, 2014. During the course of this appeal, the parties prepared for and met with the Settlement Judge appointed, with the agreement that they would attempt a global settlement of all disputed matters, including the Order on appeal. While counsel for the parties agreed to a global settlement in October, 2014, the settlement was not accepted by Eleanor, leading to a continuation of the litigation in the District Court, as well as proceeding with the matter on appeal. In summary, this has been a highly contested proceeding dealing not only with the determination of the parties’ rights under the Trust, but also issues relating to the breach of Trust, the need for an

1 accounting, the appointment of a new trustee, issues on appeal, and ongoing issues
2 relating to the administration of the Trust to the current day.

3 POINTS AND AUTHORITIES

4 At the hearing on March 20, 2015, the Court rightfully determined that
5 Jacqueline and Kathryn were entitled to an award of attorneys fees and costs payable
6 to them by Eleanor personally pursuant to the provisions of NRS 153.031(3)b). This
7 statute specifically provides for such an award when “the court determines that the
8 trustee was negligent in the performance of or breached his or her fiduciary duties.”
9 Eleanor breached her trustee fiduciary duties in the manner by which she abruptly
10 cutting of Trust income to Jacqueline and Kathryn in approximately June, 2013. This
11 improper action by Eleanor has led to costly litigation during the last two years to the
12 financial prejudice and damage of Jacqueline and Kathryn. It is only right now that
13 Eleanor be held accountable for her conduct.

14 In determining a proper award of fees and costs, the Court is guided by the
15 principles enunciated by the Nevada Supreme Court in two cases. In Nevada, “the
16 method upon which a reasonable fee is determined is subject to the discretion of the
17 court” which “is tempered only by reason and fairness.” See, *Shuette v. Beazer Homes*
18 *Holdings Corp.*, 121 Nev. 837, 864, 124 P.3d 530, 548 (2005). In exercising this
19 discretion, the Court is guided by the factors set forth in *Brunzell v. Golden Gate Nat.*
20 *Bank*, 85 Nev. 345, 349, 455 P.2d 31, 33 (1969). These factors are:

- 21 1) the advocate’s professional qualities;
- 22 2) the nature of the litigation;
- 23 3) the work performed; and
- 24 4) the result.

25 It is respectfully submitted that in applying the *Brunzell* factors to the services provided
26 to Jacqueline and Kathryn by their counsel, as documented and analyzed in their
27 counsels’ Declarations attached hereto, all of the fees and costs they incurred should
28 be awarded and reimbursed to them by Eleanor.

1 As noted in their counsels' Declarations attached hereto, Kathryn, through March
2 20, 2015, incurred a total of \$127,633.70 in legal fees and costs in this Trust
3 proceeding. Jacqueline, whose counsel has been active in this case from the beginning
4 with the filing of the initial Petition on September 27, 2013, incurred total legal fees
5 and costs, through March 20, 2015, of \$290,221.86 on her behalf in this matter.

6 As noted in the Declarations, both counsel for Kathryn and Jacqueline are
7 experienced practitioners in the area of Trust and Estate law, and such expertise was
8 required to deal with the complicated issues in this case. Kathryn's counsel, and his
9 law firm also are experienced litigation attorneys. Notwithstanding their expertise and
10 years of experience, it is believed that the hourly rates they and their law firms have
11 charged are very reasonable and fall within the median or below the median of rates
12 charged by other attorneys in Clark County, Nevada, having similar expertise and
13 dealing with similar issues.

14 The legal services provided included issues not only dealing with Trust law, but
15 also with tax laws, discovery issues, and principles of equity relevant to the issues in
16 the case. There were extensive settlement negotiations attempted, along with an appeal
17 to the Nevada Supreme Court, all of which services are set forth in the Declarations of
18 counsel attached hereto. Also attached hereto as Exhibit "A", is a chart prepared by the
19 Court outlining the various Petitions, Motions and other matters filed and placed before
20 the Court requiring the services of counsel through January 12, 2015. In addition to
21 these matters, the parties have engaged in further litigation and hearings have been held
22 in January and March of 2015, relating to the Motions for Summary Judgment, and
23 follow-up hearings to resolve remaining issues as to how to go forward with the trust
24 management, removal and replacement of the trustee, and accounting issues, as noted
25 in the copy of the Docket Sheet attached hereto as Exhibit "B".

26 Efforts have been made between counsel to not duplicate work for their clients
27 when such would not be required to present their pleadings and argument to the Court.
28 Counsel confirm that the services and costs reflected in their billing statements attached

1 to their Declarations were necessary, in their opinions, for the proper representation of
2 their clients in this proceeding. The Court has rendered a decision in favor of
3 Jacqueline and Kathryn on the main issue, as to entitlement to Trust income from Texas
4 oil properties, as well as to the removal of Eleanor as Trustee and the need for her to
5 reimburse to them all of the Trust income she has withheld from them since she took
6 over the responsibilities of Trustee and the handling of Trust income in 2012.


7 It is therefore requested that the Court now enter an order awarding to Jacqueline

**DECLARATION IN SUPPORT OF MOTION FOR
ATTORNEY'S FEES AND COSTS**

Whitney B. Warnick, Esq., being duly sworn states as follows:

1. I and my law firm are the attorneys for Kathryn A. Bouvier in the above-referenced matter.
2. In the course of this representation, and through March 20, 2015, my law firm has incurred a total of \$127,633.70 in fees and costs in prosecuting and defending in the above entitled proceedings. Attached hereto is an itemized billing statement for the services rendered and costs incurred. I affirm that the itemized services were in my opinion necessary, that there is not unreasonable duplication, and that the attached statements reflect a true and accurate account of the legal services provided to the client
3. Additional fees following March 20, 2015 are and will be incurred, and it is estimated that an additional \$10,000.00 in fees and costs may be incurred before these proceedings are resolved, barring an appeal by the opposing party.
4. I have practiced law in Nevada for over 36 years, with an emphasis in the area of Estates and Trusts and litigation. I have handled many complicated trials and appeals to the Nevada Supreme Court dealing with Trust disputes and issues.
5. My billing rate during these proceedings is \$300 an hour. I billed 455.00 hours. Other attorneys from my firm, having extensive experience in Court litigation, have also assisted and billed a few hours in this case, but for the most part I have been the primary attorney working on the case. Mr. G. Mark Albright, Esq., who has performed some services, bills at \$325 an hour, and performed 55 hours of service. Mr. William H. Stoddard, Esq., performed 0.6 hours of service and bills at \$325 an hour. Mr. D. Chris Albright, Esq., performed 1.5 hours of service and bills at \$300 an hour. Mr. Bud Albright, Esq., performed 0.4 hours of service and bills at \$300 an hour. I believe the hourly rate I and other attorneys from

1 our firm charge is the average or less than the average billing rate charged in this
2 area for the type of services we have provided, given our experience and the
3 complexity of the case. I further believe that the fees and costs incurred are
4 reasonable and significantly less than what the opposing party incurred in these
5 proceedings.

6 6. Total costs in the amount of \$5,373.70, and fees in the amount of \$155,260.00
7 were incurred for services rendered by our law firm, as shown on the billing
8 statement attached hereto. The billing statement may be a bit confusing in that
9 the services rendered and costs incurred are divided, so that approximately 50%
10 thereof could be billed to Mrs. Bouvier, and the remaining 50% billed to her
11 sister, Jacqueline M. Montoya. It was the agreement between these clients that
12 beginning in March, 2014, they would each pay one-half of the fees incurred by
13 our law firm, and those incurred by The Rushforth Firm, Ltd. Prior to that time,
14 our law firm assisted in the case as special counsel for Mrs. Montoya. Thus,
15 while it may appear that there has been a duplication of charges beginning with
16 March, 2014, billed to Mrs. Montoya and to Mrs. Bouvier, in actuality the time
17 and amount shown, and the costs incurred for each, are only one-half of the total
18 incurred by the firm on the dates listed. Thus, adding them together, gives the
19 full amount of services rendered and costs incurred.


20 7. In addition, a portion of the fees and costs incurred by Mrs. Bouvier and Mrs.
21 Montoya, relate to the Will Contest in P-14-080595-E, which was being heard
22 in this court at the same time as the Trust dispute. The Will Contest was settled
23 near the end of 2014. Therefore, \$33,000 of the fees and costs incurred, as
24 shown on the billing statement attached hereto, were allocated to the Will
25 Contest matter, for which reimbursement is not now being sought by my law
26 firm. With this amount subtracted from the total of \$160,633.70 incurred in both
27 cases, a balance in fees and costs remains of \$127,633.70, allocated solely to the
28 Trust dispute for which an award of fees and costs on behalf of my client, Mrs.

- 1 Bouvier, and Mrs. Montoya is now being requested.
- 2 8. In that the legal services rendered relating to the Will Contest were intertwined
- 3 with the services being rendered in the Trust dispute, the same services
- 4 sometimes being relevant and for the benefit of both cases, the portion allocated
- 5 to the Will Contest was determined by taking one-half of the total fees and costs
- 6 incurred from the time the Will Contest was initiated until the case was settled
- 7 and dismissed.
- 8 9. These proceedings commenced in September, 2013, and there has been ongoing
- 9 active litigation before the Court dealing with numerous legal issues involving
- 10 trusts and areas of the law related to a multitude of issues raised in these
- 11 proceedings. Because there are not many Nevada Supreme Court cases dealing
- 12 with Trust matters, research was often more complicated in looking nationwide
- 13 for guidance.
- 14 10. Efforts were made to not duplicate attorney services, both within my law firm,
- 15 and in conjunction with services being performed by The Rushforth Firm, Ltd.,
- 16 representing Mrs. Montoya in the proceedings. While paralegals and secretaries
- 17 assisted the attorneys in this case in performing valuable services, their services
- 18 were not charged separately for the most part, it being the practice of the
- 19 undersigned's law firm to include in the attorney's hourly billing rate
- 20 consideration for assistance rendered by support staff.
- 21 11. In addition to the District Court proceedings, there was an appeal to the Nevada
- 22 Supreme Court which required legal services, including extensive time spent in
- 23 attempting to reach a global settlement in these proceedings, in addition to the
- 24 specific issue being litigated on appeal.
- 25 12. I believe the issues in this case were significantly complex to the point that
- 26 expertise in the area of Trusts, litigation and appellate work, was required to
- 27 properly represent the client.
- 28 13. The Court has granted Mrs. Bouvier and Mrs. Montoya a decision in their favor

1 in these proceedings, validating the services performed on their behalf by this
2 law firm and The Rushforth law firm.

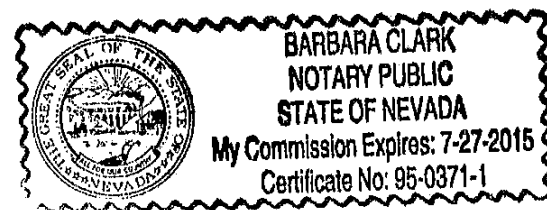

6 developing strategies/theories, preparation of evidence, research, and drafting, which
7 based on his billing rate of \$250.00 per hour equates to \$29,625.00. Layne T. Rushforth,
8 the principal of The Rushforth Firm, Ltd., has also worked on this matter. Mr. Rushforth
9 has been practicing law since 1978, originally licensed in the State of Utah, and has been
10 in practice in Clark County, Nevada since 1981. The billing rate on this matter for Mr.
11 Rushforth on this matter is \$450.00 per hour. As of January 1, 2015, Mr. Rushforth's rate
12 was increased to \$475.00, but for this matter Mr. Rushforth's rate has remained at
13 \$450.00 per hour. Through March 20, 2015, Mr. Rushforth has spent a total of 8.40 hours
14 working on this matter, including the discussion of strategy and assistance with drafting,
15 which based on his billing rate of \$450.00 per hour equates to \$3,780.80. Experienced
16 paralegal support was supplied at the rate of \$150.00 per hour and comprised 33.80 hours
17 of work on this matter, through March 20, 2015, including filing, communications with
18 the Court, and litigation and hearing preparation, which based on a billing rate of \$150.00
19 per hour equates to \$4,978.00. Lastly, through March 20, 2015, secretarial services were
20 provided as well for a total of 5.80 hours, with none of such time being billed.

- 21 5. This summary was based upon individual timesheets maintained by the attorneys and
22 support employees at The Rushforth Firm, Ltd. filled out on a regular and frequent basis.

1 The information is entered into a computer system, PC Law, where the data is stored.
2
3 Thereafter, bills are rendered to the client on a monthly basis, or thereabouts, reflecting
4 the work performed, the charges, and the costs. The client sends her remittances to The
5 Rushforth Firm, Ltd. in response to the statements and invoices mailed. These practices
6 and procedures are standard to The Rushforth Firm, Ltd. and are within its normal
7 business operations.

8
9 6. Through March 20, 2015, Ms. Montoya has incurred at total \$311,733.80 in legal fees
10 payable to The Rushforth Firm, Ltd. directly attributable to this matter.

11 7. After reviewing the time entries and evaluating the efforts necessary to create and develop
12 legal strategies and theories, research, draft and argue this matter, I believe these
13 amounts to be reasonable and appropriate, and therefore, I request on behalf of
14 Jacqueline M. Montoya that these amounts be awarded. Furthermore, upon information
15 and belief, I believe that the billing rates of The Rushforth Firm, Ltd. are either in line and
16 commensurate with, or even below and less than, other Clark County, Nevada law firms
17 possessing the comparable level of skill and expertise as The Rushforth Firm, Ltd. as it
18 relates to the area of Trusts and Estates litigation.

21 8. Through March 20, 2015, Ms. Montoya has incurred \$2,208.71 in costs directly
22 attributable to this matter in relation to The Rushforth Firm, Ltd. A breakdown of these
23 costs is contained with the billing statement attached to this Declaration.

25 9. This above mentioned sum relating to costs does not include three categories of costs
26 also relating to this matter which are as follows: 1) expert fees to Daniel T. Gerety, CPA,
27 via Gerety & Associates, CPAs; 2) legal support costs relating to and in preparation for the

- 1 February 18, 2014 evidentiary hearing via Sean Guerrero, Esq. of Stubbeman, McRae,
2 Sealy, Laughlin & Browder, Inc.; and 3) travel costs incurred for the February 18, 2014.
3
4 10. As to the Expert Fees to Mr. Gerety, Ms. Montoya has incurred total fees of \$12,748.66.
5 Attached to this Declaration as Exhibit "B" are two invoices from Mr. Gerety. One invoice
6 is dated October 29, 2014, with an invoice number of 15989, for an owing amount of
7 \$4,828.66, while the other invoice is dated October 29, 2014, with an invoice number of
8 18032, for an owing amount of \$7,920.
9
10 11. As to the fees of Sean Guerrero, Esq., an invoice dated April 9, 2014 is attached to this
11 Declaration as Exhibit "C". The legal fees for Mr. Guerrero relate to litigation support and
12 total \$4,260.00.
13
14 12. As to travel related fees, there has been a total of \$1,270.68 incurred between Kathryn
15 Bouvier and Sean Guerrero, Esq. Attached to the Application as Exhibit "D" are the
16 Southwest Airlines tickets purchased by Ms. Bouvier to attend the February 18, 2014
17 evidentiary hearing, totaling \$877.50, as well as the invoice from Mr. Guerrero reflecting
18 his hotel/lodging cost (\$551.56), airline cost (\$627.50), and ground transportation cost
19 (\$91.62) to also attend the February 18, 2014 evidentiary hearing. The February 18, 2014
20 was abruptly postponed/continued on the morning of the scheduled Trial due to the antics
21 of Ms. Ahern's prior counsel, John Mugan, Esq. and Michael Lum, Esq., in filing "last
22 minute" counterclaims against Ms. Montoya, which included requests for the award of
23 punitive damages against Ms. Montoya, which this Court indicated were improperly and
24 inappropriately filed on what effectively amounted to the eve of trial, but which would
25 nevertheless necessitate the postponement of the evidentiary hearing. At Trial, this Court
26

1 made it exceedingly clear that such tactics warranted Ms. Ahern being responsible for the
2 damages triggered.

3
4 13. A portion of the fees and costs incurred by Ms. Montoya relate to the Will Contest in P-14-
5 080595-E, which was being heard by this Court at the same time as the Trust dispute. The
6 Will Contest was settled near the end of 2014. Therefore, \$42,000 of the fees and costs
7 incurred, as shown the billing statements attached hereto, were allocated to the Will
8 Contest matter, for which reimbursement is not now being sought by The Rushforth Firm,
9 Ltd. With this amount subtracted from the total of \$313,942.51 incurred in both cases
10 through March 20, 2015, a balance in fees and costs remains of \$271,942.51, allocated
11 solely to the Trust dispute for which an award of fees and costs on behalf of my client, Ms.
12 Montoya, is requested. In addition to this sum, as discussed above, the fees and costs
13 described under sections 9, 10, 11, and 12, herein, totaling \$18,279.35 are also requested
14 to be awarded, thereby resulting in a grand total of \$290,221.86 requested. The
15 reimbursement of the airline tickets will obviously be made to Ms. Bouvier directly from
16 this sum.

20 14. Additional fees and costs following March 20, 2015 are and will be incurred, and it is
21 estimated that an additional \$10,000.00 to \$15,000.00 in fees and costs may be incurred
22 before these proceedings are resolved, barring an appeal by Ms. Ahern.
23

24 15. Efforts were made to not duplicate attorney services, both within The Rushforth Firm, Ltd.
25 and in conjunction with services performed by the law firm of Albright, Stoddard,
26 Warnick, and Albright.

27 16. In addition to the District Court proceedings, there was an appeal to the Nevada Supreme


1 Court which required legal services, including extensive time spent in attempting to reach
2 a global settlement in these proceedings, in addition to the specific issue being litigated
3 on appeal.

5 17. I believe that the issues in this case were significantly complex to the point that expertise

7 represent Ms. Montoya.

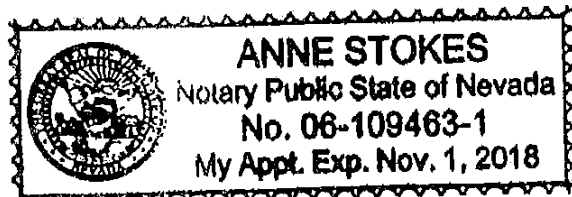
