POINTS AND AUTHORITIES

Supreme Court Rule 46 provides in pertinent part:

The attorney in an action or special proceeding may be changed at any time before judgment or final determination as follows:

- 1. Upon consent of the attorney, approved by the client.
- 2. Upon the order of the court or judge thereof on the application of the attorney or the client.

After judgment or final determination, an attorney may withdraw as attorney of record at any time upon the attorney's filing a withdrawal, with or without the client's consent.

Nevada Rule of Professional Conduct 1.16(b) states:

- (b) Except as stated in paragraph (c), a lawyer may withdraw from representing a client if:
 - (1) Withdrawal can be accomplished without material adverse effect on the interests of the client;
 - (2) The client persists in a course of action involving the lawyer's services that the lawyer reasonably believes is criminal or fraudulent;
 - (3) The client has used the lawyer's services to perpetrate a crime or fraud;
 - (4) A client insists upon taking action that the lawyer considers repugnant or with which the lawyer has fundamental disagreement;
 - (5) The client fails substantially to fulfill an obligation to the lawyer regarding the lawyer's services and has been given reasonable warning that the lawyer will withdraw unless the obligation is fulfilled;
 - (6) The representation will result in an unreasonable financial burden on the lawyer or has been rendered unreasonably difficult by the client; or
 - (7) Other good cause for withdrawal exists.

EDCR 7.40(b) states:

(b) Counsel in any case may be changed only:

•••

- (2) When no attorney has been retained to replace the attorney withdrawing, by order of the court, granted upon written motion, and
 - (i) If the application is made by the attorney, the attorney must include in an affidavit the address, or last known address, at which the client may be served with notice of further proceedings taken in the case in the event the application for withdrawal is granted, and the telephone number, or last known telephone number, at which the client may be reached and the attorney must serve a copy of the application upon the client and all other parties to the action or their attorneys, [...]

This Motion does not affect the status of the other attorney that represents

the Appellant. Kirk B. Lenhard, Esq. of Brownstein Hyatt Farber Schreck, LLP

("Brownstein") shall remain designated counsel for the Appellant.

Ms. Peterson's withdrawal will not delay this case, and is requested on the

basis that Ms. Peterson is no longer associated with Brownstein as of June 19,

2016, and therefore is no longer involved in representing the Appellant in this

case.


