7 reasonably be questioned” so that the fact in question “is not subject to reasonable
8 dispute.” *See Sheriff, Clark County v. Kravetz*, 96 Nev. 919 920, 620 P.2. 868, 689
9 (1980). In this regard the Legislative, Judicial, and Executive branches of the
10 government of the State of Nevada are “sources whose accuracy cannot reasonably
11 be questioned,” and the fact of and content contained in the public records of the
12 government of the State of Nevada “is not subject to reasonable dispute” and may be
13 judicially notices. NRS 47.130; *see Ainsworth v. Combined Ins. Co.*, 105 Nev. 237,
14 267 n.20, 774 P.2d 1003, 1024 n.20 (1989) (taking judicial notice of the public
15 records in state district court proceedings); *Jory v. Bennight*, 91 Nev. 763, 766, 542
16 P.2d 1400, 1403 (1975) (taking judicial notice of the public records of the Nevada
17 Real Estate Division indicating that Edward Jory “was the officer licensed as broker
18 on behalf of the corporation”); *see also Chas. L. Harney, Inc. v. State*, 31 Cal.Rptr.
19 524, 529 (Ct. App. 1963) (taking judicial notice of the “official records and files of
20 the State Board of Control and of the office of the State Controller”).



NOTICE OF AND PETITION FOR JUDICIAL REVIEW
(Re: Permits 84309 and 84310)

COME NOW J.W. BENTLEY and MARYANN BENTLEY, Trustees of the Bentley Family 1995 Trust, by and through their undersigned counsel, and hereby petition this Court for judicial review of the State of Nevada, Office of the State Engineer's ("State Engineer") issuance of Permit Nos. 84309 and 84310 to Change the Public Waters of the State of Nevada Heretofore Appropriated issued on January 29, 2015, copies of which are attached hereto as Exhibits "1" and "2" and incorporated herein by reference. Notice of this petition is given pursuant to NRS 533.350 (3).

In support of this Petition, Petitioners allege as follows:

1. This Petition for Judicial Review is filed pursuant to NRS 533.450.

///

1 2. Jurisdiction and venue lies with this Court in that the streams that are the subject of
2 the permits are located in Douglas County and subject to a decree entered by the Ninth Judicial
3 District Court in Case No. 08-CV-0363 on September 29, 2014.

4 3. Petitioners are the joint owners of vested water rights, Proofs V-06305 and V-
5 06306, to the waters of the North Diversion of Sheridan Creek and the commingled waters of
6 Stutler Creek (collectively "North Sheridan Creek").

7 4. Petitioners have an interest in permit 7595, Certificate 1760, to the waters of
8 Gansberg Springs, which are also commingled with the waters of the North Sheridan Creek.

9 5. On September 4, 2014, Petitioners submitted Application Nos. 84309 and 84310 to
10 change the manner of use of the aforementioned proofs from irrigation to recreation purposes to
11 maintain water levels in ponds for fish habitat – propagation.

12 6. The State Engineer approved the aforementioned applications on January 29, 2015,
13 subject to conditions stated therein which require Petitioners to rotate their use of vested water
14 rights and their interest in Permit 7595, Certificate 1760.

15 7. Petitioners do not agree with or consent to the Rotation Schedule.

16 8. Petitioners are aggrieved by the conditions of approval and the interest of
17 Petitioners has been injured because the conditions impair their vested, certificated, and permitted
18 water rights.

19 9. Petitioners are aggrieved by the Rotation Schedule as it is (a) in violation of
20 constitutional or statutory provisions, (b) is in excess of the statutory authority of the State
21 Engineer to impose, (c) is affected by other error of law, (d) is not supported by substantial
22 evidence, and/or is arbitrary or capricious or characterized by abuse of discretion.

3. For such other and further relief as the Court deems just and proper.


