

2 Court heard argument from Counsel. The Court has Jurisdiction to deal with issues, as the
3 argument is collateral to matter on APPEAL.

4 **THEREFORE, IT IS ORDERED** that both parties will notify the other party in writing
5 regarding travel, leaving town as to where they will be with the child and provide contact phone
6 numbers in the event of an emergency.



17 **IT IS SO ORDERED.**


