ORDER RE: TRANSCRIPTS


Appellant's counsel has filed a motion for an extension of time to file the fast track statement and appendix, in which counsel informs this court that the transcripts requested from court reporter Brenda Schroeder have not yet been received.¹ To date, Ms. Schroeder has not filed the notice of delivery required by NRAP 3C(d)(3)(E)(ii). Ms. Schroeder shall have 14 days from the date of this order to (1) file the requested transcripts in the district court and deliver the transcripts to counsel, if she has not already done so, and (2) file a notice of delivery with the clerk of this court in compliance with NRAP 3C(d)(3)(E)(ii).² Failure to
