14 (20) days from the date of service of this document to prepare an  
15 original plus two copies at State expense and file with the  
16 District Court Clerk the original rough draft transcript(s)  
17 requested herein.

19 Further, pursuant to NRAP 3C(d)(3)(iii), the court  
20 reporter shall also deliver copies of the rough draft transcript  
21 to appellant's counsel and respondent counsel no more than twenty  
22 (20) days after the date of the appellant's request.
