

IT IS HEREBY STIPULATED that Eric's and the ELN Trust's counsels have received and reviewed the Motion for Extension of Time to File Answering Brief on Appeal and Opening Brief on Cross-Appeal filed by Lynita, and have no Eric similarly requires an extension of time to file his objection to same. Answering Brief on Appeal and Opening Brief on Cross-Appeal, and the parties respectfully request that the Court further revise the deadlines in this matter as set forth herein.


