Appellant CITY OF FERNLEY, NEVADA (hereinafter "Fernley"), by and through its attorneys of record, the law firm of Brownstein Hyatt Farber Schreck, LLP, hereby submits this Notice regarding the status of its filing and service of a transcript request form in response to Respondents' Joint Notice Directing Appellant To File Transcript Request Form Pursuant To NRAP 9 filed on December 2, 2014 (the "Joint Notice").

POINTS AND AUTHORITIES

I. FERNLEY IS SEEKING TO OBTAIN THE TRANSCRIPT REQUESTED BY RESPONDENTS.

On December 1, 2014, Fernley filed and served its "Certificate That No Transcript Is Being Requested" because no court reporter was present at the substantive hearing held in the District Court on September 2, 2014 (the "September 2nd Hearing"). Despite the absence of a court reporter, on December 2, 2014, Respondents filed and served their Joint Notice pursuant to NRAP 9(a)(5), which directed Fernley to file and serve, within 10 days, "a transcript request form to request preparation of the transcript of the entire September 2, 2014 district court hearing." *See* Respondents' Joint Notice, at 2 (filed Dec. 2, 2014). Respondents' represented in their Joint Notice that "a verbatim record was made of the hearing using sound recording equipment as authorized by NRS 3.380." *See id.* at 1. Although Respondents provided no evidence that the recording referred to by them was made using sound recording equipment authorized by NRS 3.380, Fernley has begun the process of obtaining a transcript of the September 2nd Hearing for the Court and the parties in order to comply with Respondents' Joint Notice.

Fernley files this notice to inform the Court and Respondents that it cannot yet file the transcript request form provided for by NRAP 9(a)(5) because of certain District Court's procedures for obtaining a transcript that apply to this case. Not only was there no court reporter for the September 2nd Hearing, Fernley's counsel has been advised by the District Court Clerk's Office that there also was no

designated court recorder on which to serve a copy of a transcript request form pursuant to NRAP 9(a)(3)(B). Rather, in accordance with the District Court's procedures, Fernley's counsel has ordered from the District Court a disk that contains a recording of the September 2nd Hearing, which it must then deliver to a court reporting service of its choosing for transcription. Until Fernley's counsel receives the disk from the District Court, which it will then immediately deliver to a court reporting service for transcription, it will be unable to file and serve a transcript request form relating to the September 2nd Hearing.

In sum, Fernley will file and serve a transcript request form relating to the September 2nd Hearing, directed to the appropriate court reporter, upon its receipt of the disk from the District Court and immediate delivery of the disk to a court reporting service for transcription.
