ENTRY OF JUDGMENT AND IMPOSITION OF SENTENCE

Deputy District Attorney Roy Stralla was present on behalf of the State. Defendant was present with counsel, Deputy Public Defender Evelyn Grosenick. Jennifer Iveson was present on behalf of the Division of Parole and Probation. Pretrial Services Officer Scott Higginbotham was present in the gallery.

COURT reviewed the procedural history of the case.

Defense counsel advised the Court that the Defendant's updated credit for time served is 276 days; Ms. Iveson concurred.

Defense counsel presented mitigating statements on behalf of the Defendant; and she further gave the Court information regarding the offense. Defense counsel advised the Court that the Defendant has been accepted into the Salvation Army, and she urged the Court to place the Defendant on probation; or in the alternative, sentence him to 12-30 months in prison. Defense counsel further presented argument regarding the Division of Parole and Probation's scoring system.

State's counsel responded; and he further gave the Court information regarding the Defendant's criminal history. State's counsel further argued that the Defendant deserves the maximum prison sentence.

Defendant addressed the Court on his own behalf.

COURT ORDERED: Defendant adjudged guilty and sentenced to imprisonment in the Nevada Department of Corrections for the maximum term of one hundred twenty (120) months with the minimum parole eligibility of forty-eight (48) months, with credit for two hundred seventy-six (276) days time served. It is further ordered that the Defendant shall pay the statutory Twenty-Five Dollar (\$25.00) administrative assessment fee; that he shall submit to a DNA analysis test for the purpose of determining genetic markers and pay a testing fee in the amount of One Hundred Fifty Dollars (\$150.00), if not previously ordered; that he shall pay the Three Dollar (\$3.00) administrative assessment fee for obtaining a biological specimen and conducting a genetic marker analysis; and that he shall reimburse Washoe County in the amount of Five Hundred Dollars (\$500.00) for legal services rendered. It is further ordered that the fees are subject to removal from the Defendant's books at the Washoe County Jail and/or Nevada Department of Corrections. Defendant remanded to the custody of the Sheriff.
