- 1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.
- Our office filed the Notice of Appeal in this matter on December 2, 2014. The
 Opening Brief was originally due to be filed on April 1, 2015. Court recorder Garibay filed a
 Motion for Extension on December 22, 2014.
