THE FUTURE. I ALSO ASKED FOR COPIES OF MY APPEAL ORDER #61089, DC. 17-41371,

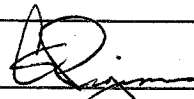
I AM HOPEING AND DOUBT THAT THE RE-OPENING OF THIS SECOND APPEAL
