

ORDER GRANTING MOTION TO ASSOCIATE COUNSEL

Respondents David A. Harris and National Jewish Democratic Council have filed a motion to associate attorney Gayle Chatilo Sproul of Levine Sullivan Koch & Schulz, LLP, pursuant to SCR 42. Attached to the motion to associate Sproul is a verified application; certificates of good standing from the Supreme Court of Pennsylvania; Supreme Court, Appellate Division of the State of New York; the Supreme Court of New Jersey; the District of Columbia Court of Appeals; and a statement pursuant to SCR 42 from the State Bar of Nevada. The State Bar of Nevada's Rule 42 statement indicates that Sproul has not applied to appear in Nevada courts within the past 3 years. See SCR 42(6) (stating that repeated appearances by any person pursuant to this rule shall be cause for denial of the motion). Accordingly, we grant the motion to associate. SCR 42(8). Sproul shall be permitted to appear on behalf of respondents in this matter. Nevada attorney J. Colby Williams of Campbell & Williams shall be responsible for all matters presented by Sproul in this appeal. See SCR 42(14)(a) (requiring the Nevada attorney of record to be responsible for and actively participate in the representation of a client in these proceedings); NRAP 25(a)(5) (requiring all documents submitted to the supreme court for filing to include the

original signature of at least one attorney of record who is an active member of the State Bar of Nevada); NRAP 46(a)(3) (requiring Nevada counsel to sign all briefs, be present during oral argument, and be responsible for all briefs and matters presented by foreign counsel)

It is so ORDERED.
