JONELL THOMAS, hereby declares as follows:

I am an attorney duly licensed to practice law in the State of Nevada, and the

Deputy Special Public Defender assigned to handle Mr. Jeremias' capital appeal.

I have completed my review and summary of the lengthy, 27 volume, record and have determined the issues to be presented. I have conducted research for many of the issues, but there are issues of first impression which require additional research and review. I have drafted much of the brief, but additional drafting is required and the brief will require extensive editing. The attorney in my office who assists with my editing has been in trial and unavailable.

I am attorney of record for <u>Burnside v. State</u>, a capital case. After this Court entered its Order regarding the first request for an extension of time in this case, this Court issued its Opinion in the <u>Burnside</u> case.
