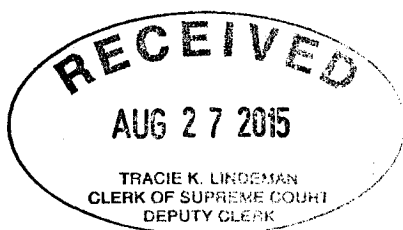

## I. SUMMATION
