1                    **MEMORANDUM OF POINTS AND AUTHORITIES**

2            On April 1, 2016 this Court issued a Notice of Oral Argument Setting  
3 which set oral argument for May 10, 2016. The issue before the Court in this  
4 appeal is whether the district court abused its discretion in the amount of  
5 attorney's fees awarded to Appellant pursuant to a Special Motion to Dismiss filed  
6 under Nevada's Anti-SLAPP statutes. See NRS 41.670.

7            However, the appeal over whether that Special Motion to Dismiss should  
8 have been granted in the first instance is currently pending before the Court in  
9 Docket No. 68994, and has not yet even been briefed due to the fact that the  
10 original appeal on this issue was dismissed on ripeness grounds in Docket No.  
11 66858. It was only on March 30, 2016 that this Court reinstated the briefing  
12 schedule in Docket No. 68994 after denying a Motion to Dismiss.

13           A review of the Docketing Statement filed in connection with this appeal  
14 will reveal that the basis for the court's appellate jurisdiction is that the award of  
15 fees constitutes a "special order entered after final judgment" pursuant to NRAP  
16 3(A)(8). If the Court reverses the final judgment in connection with the appeal in  
17 Docket No. 68994, it will not need to decide whether the amount of attorney's  
18 fees was inadequate in connection with this appeal.

19           This Court's resources are "valuable and limited". *Pan v. Eighth Judicial*  
20 *District Court*, 120 Nev. 222, 229, 88 P.3d 840, 844 (2004). Holding oral

1 argument on the *amount* of fees awarded, prior to deciding the underlying case as  
2 to *whether* the Special Motion to Dismiss should have been granted in the first  
3 place, is not the best use of those valuable and limited judicial resources.

4 For all of the reasons set forth above, Respondents request that the Oral  
5 Argument be vacated and this appeal consolidated with Docket No. 68994.
