MEMORANDUM OF POINTS AND AUTHORITIES

Pat Songer has filed a Motion to Reconsider Motion for Reconsideration by The Full Court Per Rule 27(c)(2) in Case No. 68994 and basis this opposition on that pending motion. Mr. Songer is entitled to review of the denial pursuant to NRAP 27(c)(2) and thus the future of appeal No. 68994 is uncertain. Thus, any consolidation at this juncture would be premature.

As consolidation would be premature, so too would vacating the oral arguments scheduled for May 10, 2016. Mr. Delucchi and Mr. Hollis' pending appeal in case No. 68994 is an untimely second appeal on the issue of anti-SLAPP. Mr. Songer's pending appeal is the only valid appeal from a final judgment on this case and thus oral arguments on the issue of the prevailing market rate for attorney's fees can, and should, proceed in due course. Should the Court dismiss the untimely appeal, then the only issue left to resolve would be the one on the prevailing market rate. Thus, Mr. Songer asks this Court deny this motion.
