

#### FINDINGS OF FACT, CONCLUSIONS OF LAW

This is Eddie Rencher Jr.'s ("Defendant") Petition for Writ of Habeas Corpus. On August 31, 2006, Defendant was charged by way of Information with Counts 1 through 14 – Sexual Assault of a Child Under Fourteen Years of Age (Felony – NRS 200.364, 200.366) and Counts 15 through 20 – Lewdness with a Child Under Fourteen years of Age (Felony – NRS 201.230). Defendant's jury trial commenced on July 7, 2008. Defendant was found guilty of Counts 1, 3, 4, 5, 6, 7, 11, 12, 14, 15, 16, 17, 18, 19, and 20. On August 27, 2008, Defendant was sentenced to fifteen terms of life without the possibility of parole, two of which were ordered to run consecutively. The Judgment of Conviction was filed on September 23, 2008. Defendant filed a Notice of Appeal on September 5, 2008. On November 5, 2009, the Nevada Supreme Court affirmed Defendant's conviction. Remittitur was issued on December 1, 2009.

Defendant filed a pro per Petition for Writ of Habeas Corpus (Post-Conviction) on March 4, 2010. The State filed a response on May 18, 2010. Defendant's court-appointed counsel filed a supplemental petition on January 28, 2011. The State filed an Opposition to Defendant's Supplemental Petition on March 24, 2011. On June 17, 2011, the District Court denied Defendant's Petition. The Findings of Fact, Conclusions of Law and Order was filed on August 15, 2011. The Notice of Entry was filed on September 20, 2011.

Defendant filed a second Notice of Appeal on September 23, 2011. On June 13, 2012, the Nevada Supreme Court affirmed the district court's denial of Defendant's Petition for Writ of Habeas Corpus (Post-Conviction). Remittitur was issued on July 9, 2012.

Defendant then filed a Federal Petition for Writ of Habeas Corpus (Post-Conviction). On August 18, 2014, the United States District Court for the District of Nevada found that Defendant's Petition contained both exhausted and unexhausted claims and was subject to dismissal.

On November 21, 2014, Defendant filed the instant state Petition for Writ of Habeas Corpus (Post-Conviction). On January 7, 2015, the State filed a Response and Motion to Dismiss Defendant's Petition.

#### **Petition Claims**

NRS 34.726 requires habeas petitions to be filed within one year after remittitur on the direct appeal, absent a showing of good cause for the delay and actual prejudice. The Nevada Supreme Court issued remittitur on December 1, 2009. As such, Defendant had until December 1, 2010, to file a timely habeas petition. Defendant did not file the instant Petition until November 21, 2014. Accordingly, the Court finds that Defendant's Petition is untimely.

Additionally, NRS 34.810 requires a court to dismiss a post-conviction habeas petition if its grounds could have been raised in an earlier proceeding, or were raised earlier and were decided on the merits, unless the petitioner demonstrates good cause for failing to present the claims earlier and actual prejudice. Defendant filed his first habeas Petition on March 4, 2010. Therein, Defendant asserted that trial counsel was ineffective. In the instant Petition, Defendant argues that the district court improperly admitted prior bad act evidence, and that trial counsel was ineffective for failing to present the evidence of a child psychiatrist. These issues could have been raised during Defendant's direct appeal and in Defendant's first habeas Petition. Accordingly, the Court finds that Defendant's failure to do so constitutes an abuse of the writ.

A petitioner may, however, overcome the procedural bars if he can show good cause and prejudice. NRS 34.726(1); NRS 34.810(3). To show good cause for delay under NRS 34.726(1), a petitioner must demonstrate the following: 1) "[t]hat the delay is not the fault of the petitioner" and 2) that the petitioner will be "unduly prejudice[d]" if the petition is dismissed as untimely. NRS 34.726(1). To avoid the procedural default under NRS 34.810, Defendant has the burden of pleading and proving specific facts that demonstrate both good cause for his failure to present his claim in earlier proceedings and actual prejudice. NRS 34.810; Hogan v. Warden, 109 Nev. 952, 959-60, 860 P.2d 710, 715-16 (1993); Phelps v. Director, 104 Nev. 656, 659, 764 P.2d 1303, 1305 (1988). Under the first requirement of both, "a petitioner must show that an impediment external to the defense prevented him or her from complying with the state procedural default rules." Hathaway v. State, 119 Nev. 248, 252, 71 P.3d 503, 506 (2003) (citing Pellegrini v. State, 117 Nev. 860, 886-87, 34 P.3d 519, 537

(2001); Lozada v. State, 110 Nev. 349, 353, 871 P.2d 944, 946 (1994); Passanisi v. Director, Dep't Prisons, 105 Nev. 63, 66, 769 P.2d 72, 74 (1989). "An impediment external to the defense may be demonstrated by a showing 'that the factual or legal basis for a claim was not reasonably available to counsel, or that some interference by officials, made compliance impracticable." Id. (quoting Murray v. Carrier, 477 U.S. 478, 488, 106 S.Ct. 2639 (1986) (citations and quotations omitted)). Good cause for the delay is defined as "a substantial reason; one that affords a legal excuse." Colley v. State, 105 Nev. 235, 236, 773 P.2d 1229, 1230 (1989).

In an attempt to show good cause, Defendant argues that the procedural defaults were due to ineffective post-conviction counsel. However, the Court finds that Defendant's argument does not establish good cause. Defendant cannot allege ineffective assistance of counsel, or lack of counsel, on post-conviction as good cause where he was not entitled to the appointment of counsel. See Crump v. Warden, Nevada State Prison, 113 Nev. 293, 303, 934 P.2d 247, 253 (1997). Here, Defendant was not entitled to the appointment of counsel for his first Petition for Writ of Habeas Corpus. See Coleman v. Thompson, 501 U.S. 722, 752 (1991); McKague v. Warden, 112 Nev. 159, 912 P.2d 255 (1996); Peterson v. Warden, Nevada State Prison, 87 Nev. 134, 483 P.2d 204 (1971) (citing former statute NRS 177.345(2)); NRS 34.750; compare NRS 34.820(1)(a) (entitling appointed counsel when Petitioner is under a sentence of death). As such, the Court finds that Defendant has not demonstrated good cause.

Furthermore, the Court finds that Defendant's pursuit of federal habeas relief does not constitute good cause. Defendant filed his Petition after the United States District Court ordered Defendant to exhaust his remedies at the state level. However, a return to state court to exhaust remedies for federal habeas is not good cause to overcome state procedural bars. Shumway v. Payne, 223 F.3d 982 (9th Cir. 2000).

The Court finds that Defendant's Petition is both untimely and successive per NRS 34.726, and NRS 34.810. The Court further finds that Defendant has not demonstrated good cause to overcome the procedural bars. Accordingly, Defendant's Petition is dismissed.

The Court finds that Defendant's Petition is both untimely and successive per NRS 34.726, and NRS 34.810. The Court further finds that Defendant has not demonstrated good cause to overcome the procedural bars. Accordingly, Defendant's Petition is dismissed.
