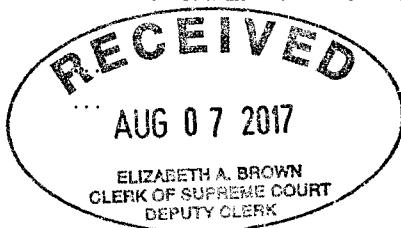
Re: Permanent Nevada Statewide Guardianship Commission

To Whom it May Concern:

I would like to be considered for participation on the permanent Nevada Guardianship Commission. I have attended many meetings of the prior commission, read much of the materials, and even presented to the commission in the past. Since that time when I was a private attorney in the field of guardianship and elder exploitation, I have become the Attorney for the Rights of Older Persons and Persons With Disabilities with the State of Nevada Aging and Disability Services Division.

My role with the state is codified in NRS 427A.1234 (as amended by Assembly Bill 31) and I assumed the role Sally C. Ramm, Esq. previously held in January 2017. I have been able to participate in the legislative session as guardianship bills made their way through the process and have been participating with trainings and outreach about the new laws. I am also the state legal services developer under the federal Older Americans Act and therefore have experience with access to justice issues and funding for representation of protected persons.

Part of what brought me to close my private practice in Las Vegas, Nevada and move to Northern Nevada this year was the prospect of preventing guardianship abuses instead of seeing them mid-stream as I previously had. Having practiced in Clark County primarily since being admitted to the bar 10 years ago, I have the unique perspective of someone who has seen the guardianship crisis first hand. I even successfully represented a protected person against her former guardian, April Parks, and assisted law enforcement with their pursuit of charges against Parks related to other cases.

On the flip side, I have been able to explore the rural areas of Nevada and make contacts with people there since my relocation. I have seen the different issues faced as we strive to allow people self-determination and the ability to age in place. I have participated with groups from the End Abuse in Later Life Grant with the Nevada Attorney General's Office (I am a member of the Coordinated Community Response Team) to the Supported Decision Making Grant Research Team looking at alternatives to guardianship.
