Re: Letter of Interest re Permanent Guardianship Commission

Dear Justice Hardesty and Commission Members:

I am writing to express my interest in serving on the permanent Guardianship Commission and my eagerness to help address the various issues of concern to those individuals facing or under guardianship. I applaud and admire the Guardianship Commission's past efforts and recent legislative success and would very much like to be involved in the next phase of the Commission's work.

In my position as directing attorney of Legal Aid Center of Southern Nevada's Guardianship Advocacy Project, my legal practice focuses exclusively on guardianship and the protection of seniors and disabled individuals who find themselves involved in the guardianship process. As such, I see the terrific strides that have been made thanks to the Commission's efforts, and I also see those areas awaiting the Commission's attention. I am especially excited about the prospect of the Commission's development of new procedural rules to govern, instruct, and standardize the practice in guardianship cases. Ultimately, I am confident the Commission's efforts will serve to provide safeguards for those people facing or under guardianship, and, so, the Commission's work supports and enables the mission of Legal Aid Center of Southern Nevada and my work there.

As you will see from the enclosed resume, in addition to my current work in guardianship, I have over twenty years of legal experience, both in private practice and public interest. Before joining Legal Aid Center of Southern Nevada, I was a partner at a regional law firm, Lewis and Roca, where I practiced primarily in the areas of complex business and commercial litigation. I left that firm to join Legal Aid Center in 2009 and to open the Civil Law Self-Help Center at the Regional Justice Center in Las Vegas, which I ran for the next six years until I became Legal Aid Center's Director of Development in 2015. After leaving for a brief period, I returned to Legal Aid Center in March of this year to be part of its important work in guardianship, knowing that I could protect and give voice to those most vulnerable and be part of the groundbreaking guardianship reforms being championed in Nevada.

I believe my legal experience in both the private and public arenas can be put to good use on the Guardianship Commission, and I sincerely hope you will consider me for appointment and allow me to assist the Commission's ongoing efforts.
