The Honorable Justices of the Supreme Court of the State of Nevada:

I, Ross E. Evans, Esq., Nevada bar number 11374, hereby request the Court's consideration for appointment to serve on the Court's permanent Guardianship Commission. I am an associate attorney at the law firm of Solomon Dwiggin & Freer, Ltd., in Las Vegas, Nevada, which firm specializes in the areas of guardianship, trusts, and estates, in both administration and litigation. Since my admission to the State Bar of Nevada in 2009, I have become heavily interested in guardianship matters. I have had experience representing clients in matters pertaining to both adult and minor protected persons, and which matters have spanned from simple to highly contentious.

Moreover, I have witnessed first-hand and paid close attention to the significant and newsworthy issues involving the exploitation and financial abuse faced by some of our State's most vulnerable citizens. 

and both litigating and defending against allegations of misconduct by a guardian or fiduciary. As a practitioner in the field of trust and estate administration and litigation, I also have experience in issues involving the protected person's estate planning, including revocable and irrevocable trusts, special needs trusts, and third party trustee / fiduciaries, which issues are often intermingled in guardianship proceedings.

I recognize a need for a broad top to bottom review of our guardianship laws and practices, from both modernization and safeguarding perspectives, as well as for practicality for all of those involved. I believe my practice experience in this field would greatly benefit the Commission as it seeks to reshape the future of Guardianship in Nevada.
