9 **NOTICE OF ATTEMPT TO FILE THE REQUEST FOR TRANSCRIPT**
10 **AND REQUEST FOR SUBMISSION OF THE REQUEST FOR**
11 **TRANSCRIPT FORM**

12 On August 27, 2015, Daniel W. Anderson, Esq. filed a Motion to Extend Time to file the
13 Request for Transcript. On September 3, 2015, the Court granted the Motion to Extend but
14 rejected the submission of the Transcript Request Form. The form was rejected as it did not bear
15 the file-stamped of the District Court Clerk pursuant to NRAP 9(a). Counsel was granted five
16 (5) days from September 3, 2015, in which to file the Request.

17 On September 8, 2015, counsel delivered the Request for Transcript with a copy of the
18 Order from this Court to the Clerk's Office at Family Court for filing. The clerk refused to file
19 the Request and verified with the Lead Supervisor of the Clerk's Office, Shelly, that the Court
20 Clerk does not file the Request for Transcript, a copy of the Request is attached as Exhibit "1".

21 On August 26, 2015, counsel had requested the transcripts from Video Transcript at the
22 Clark County Family Court and posted an initial deposit of \$110.00. See Exhibit "2". On
23 September 8, 2015, counsel was notified that the transcripts were available and there was a
24 balance of \$21.35. Counsel's runner picked up the transcripts on September 8, 2015. See Final
25 Billing of Transcripts attached as Exhibit "3". Sherry Justice of the Video Transcript
26 Department submitted a Certification of Transcripts/Notification of Completion and submitted it
27 to the Supreme Court on September 8, 2015. See Exhibit "4". Ms. Justice also provided a file-
28 stamped copy of the Receipt of Copy and Certification to counsel.

1 Daniel Anderson, Esq. has made every attempt to comply with NRAP 9(a) and submit the
2 Request for Transcript to the County Clerk's Office for filing prior to submission to the Supreme
3 Court Clerk's Office as directed in the Order Granting Motion... filed by the clerk on September
4 3, 2015, but the document was not accepted by the County Clerk's Office. Therefore, counsel is
5 re-submitting a copy of the Request as referenced in Exhibit "1".

6 Based on the foregoing, counsel requests that the Request for Transcript be accepted for
7 filing. As noted above, the Request must be submitted by September 10, 2015 to be in
8 compliance with the Order. If not approved, counsel requests additional time.


