### **MEMORANDUM**

I, CHRIS BURTON, am the assigned attorney for the Appellant in the above-captioned case. This Court may extend the time to file any brief upon a showing of good cause. NRAP 26(b)(1)(A).

The State's Opening Brief on the instant matter is currently due on August 25, 2015. This is an appeal from the granting, in part, of a pre-trial Petition for Writ of Habeas Corpus. Based on the State's research to date, the issue is somewhat one of first impression in this State and requires significant analysis of statutory construction. Further, as the statute at issue is the law criminalizing sexual assault, the issue to be presented is one of state-wide importance. Not only does the issue require considerable legal research, but the record to date is already somewhat voluminous, including a five-day preliminary hearing transcript. The State therefore requires additional time to complete its Answer.
