I am the chief appellate deputy with the Nevada State Public 6 Defender, appointed counsel for the appellant. 7 2. The Appellate Division of the Nevada State Public Defender 8 prosecutes appeals, petitions for post-conviction relief, and writs of habeas 9 corpus on behalf of indigent criminal defendants. In addition to handling 10 appeals and post-conviction litigation, the Appellate Division of the Nevada 11 State Public Defender processes and responds to numerous letters from inmates 12 in this and other states. Further, we sometimes are called upon to handle court 13 appearances in various counties at times when trial deputies have scheduling 14 conflicts and during periods of personnel shortage. 15 3. This is an appeal from a Judgment of Conviction entered 16 pursuant to a guilty plea of Conspiracy to Commit Grant Larceny. 17 4. My appellate deputy has recently left the office on maternity 18 eave. I am now covering cases in the Carson City court system as well as 19

working on her appeals caseload, parole revocations, and any other work that
