ineffective. *Rubio v. State*, 124 Nev. 1032, 194 P.3d 1224 (2008); *Browning v. State*, 120 Nev. 347, 91 P.3d 39 (2004); *Thomas v. State*, 120 Nev. 37, 83 P.3d
818 (2004).

The inclusion of the attorney's name in the opinion is irrelevant to the
issue presented and the Court's decision. The inclusion of any attorney's name
could be constructed as if the Court were issuing a public censure in this case,
which does not appear to be the Court's intent.
