Norman Demetrius Dupree is guilty of the crime of Domestic Battery by Strangulation, a violation of NRS 200.481(h) and NRS 200.485(2) and NRS 33.018, a felony, as charged in the Information, and that he be punished by imprisonment in the Nevada State Prison for a minimum term of Twenty-Four (24) months to a maximum term of Sixty (60) months, to be served consecutively to the sentence imposed in Case No. CR14-0058, with Zero (0) days credit for time served.

It is further ordered that the Defendant shall pay the statutory Twenty-Five Dollar (\$25.00) administrative assessment fee, the Three Dollar (\$3.00) administrative assessment fee for obtaining a biological specimen and conducting a genetic marker

analysis, the domestic violence fee in the amount of Thirty-Five Dollars (\$35.00), and attorney's fees are hereby waived by the Court.

Any fine, fee or administrative assessment imposed upon the Defendant today as reflected in this Judgment of Conviction constitutes a lien, as defined in Nevada Revised Statutes (NRS 176.275). Should the Defendant not pay these fines, fees or assessments, collection efforts may be undertaken against him.
