MEMORANDUM

NRAP 3C(i)(2) provides:

Additional Extensions by Motion. Subsequent extensions of time for filing fast track statements and responses, and supplemental fast track statements and responses shall be granted only upon motion to the Supreme Court. The motion shall justify the requested extension in light of the time limits provided in this Rule, and shall specify the exact length of the extension requested. Extensions of time for the filing of fast track statements and responses, and supplemental fast track statements and responses shall be granted only upon demonstration of extreme need or merit. Sanctions may be imposed if a motion is brought without reasonable grounds.

On May 29, 2015, counsel for the Appellant, Christopher Roach, sent correspondence to him while incarcerated at Clark County Detention Center, and on June 19, 2015, a second letter was mailed to Mr. Roach at High Desert State Prison. Counsel directed Mr. Roach to send a reply detailing the grounds for the instant appeal. As of the writing of the instant motion, Mr. Roach has not sent correspondence, nor is counsel aware of any attempt at communication by Mr. Roach. Counsel is unaware of any appealable issues, and without communication from Mr. Roach, a Fast Track Statement cannot be properly filed.

The current deadline of July 7, 2015, does not afford counsel enough time to send further correspondence and for Mr. Roach to send return correspondence, in order to properly and effectively prepare the Fast Track Statement and Appendix. If this extension of time is granted, counsel does not anticipate requiring any further extensions of time. This request for an extension of time is meritorious, otherwise, defense counsel would be unable to render effective assistance with regard to the briefing of appellate issues.
