**MOTION TO STAY BRIEFING  
SCHEDULE**

Respondent, Susan Fallini, by and through her attorney of record, David R. Hague, hereby respectfully submits this Motion to Stay Briefing Schedule. Respondent is submitting this motion pursuant to Nevada Rules of Appellate Procedure 27. On March 18, 2016, Respondent filed with this Court a Motion to Dismiss for Lack of Appellate Jurisdiction (the “**Motion to Dismiss**”) in accordance with Nevada Rules of Appellate Procedure 14(f), which provides that “[i]f respondent believes there is a jurisdictional defect, respondent should file a motion to dismiss.” *See* NRAP 14(f). As set forth in the Motion to Dismiss, Respondent asserts that the Court lacks jurisdiction over Appellant’s untimely appeal. Because the Motion to Dismiss is currently pending before this Court, Respondent respectfully requests a stay on the briefing schedule, as the Court’s jurisdictional determination will have a material impact on the scope and substance of Respondent’s Answering Brief. It would be expensive and inefficient to have Respondent prepare her Answering Brief prior to the Court’s determination as to its jurisdiction. Accordingly, Respondent requests that this Court make an

1 expedited decision under Rule 2 of the Nevada Rules of Appellate Procedure  
2 regarding this Motion to Stay Briefing.
