**STIPULATION TO PERMIT ELAINE WYNN TO FILE AN ANSWERING  
BRIEF AS A REAL PARTY IN INTEREST**

Whereas, the District Court entered an order on June 23, 2015 denying Petitioner Kazuo Okada's Motion for a Protective Order to (1) Locate His Deposition in Tokyo and (2) Set it for Three Days (the "Order");

Whereas, the Order provides that Petitioner's deposition will proceed in Las Vegas for up to ten (10) days, with the last of those days allocated to questioning by counsel for Elaine Wynn;

Whereas, Petitioner has filed a Petition for Writ of Prohibition or Mandamus challenging the Order identifying only Wynn Resorts Limited as the Real Party in Interest;
