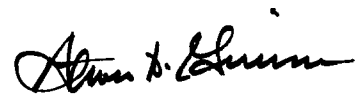

Pursuant to Rule 3(f) of the Nevada Rules of Appellate Procedure ("NRAP"), Michael Joseph Jeffries, Defendant in the above-entitled matter, by and through his attorney, Vincent Savarese III, Esq., of the law firm of Gentile Cristalli Miller Armeni & Savarese, hereby respectfully submits the following Case Appeal Statement:

1. The Appellant filing this Case Appeal Statement is Defendant Michael Joseph Jeffries.
2. The judge who issued the Judgment of Conviction and all decisions and orders appealed from is the Honorable J. Charles Thompson, Senior Judge of the Eighth Judicial District Court in and for Clark County, Nevada.
3. Defendant/Appellant Michael Joseph Jeffries is the only Appellant in this matter; and appellate counsel for Defendant/Appellant Jeffries is Vincent Savarese III, Esq., of the law firm of Gentile Cristalli Miller Armeni & Savarese, 410 South Rampart Boulevard, Suite 420, Las Vegas, Nevada 89145.

4. Plaintiff/Respondent State of Nevada is the only Respondent in this matter; and the above-named counsel for Defendant/Appellant Jeffries does not know at this time who will act as appellate counsel for Plaintiff/Respondent State of Nevada. However, the following attorneys represented Plaintiff/Respondent State of Nevada in this matter in the trial court: Steven B. Wolfson, District Attorney in and for Clark County, Nevada; Bernard Zadrowski, Chief Deputy District Attorney; and Nickolas Graham, Deputy District Attorney, of the Clark County District Attorney's Office Criminal Division, Regional Justice Center, 200 Lewis Avenue, Third Floor, Las Vegas, Nevada 89155.
5. To the best of the knowledge and belief of the undersigned counsel for Defendant/Appellant Jeffries, each and every attorney identified above in paragraphs 3 and 4, *supra* is licensed to practice law in the State of Nevada.
6. Defendant/Appellant Jeffries was represented by court appointed counsel in the district court.
7. Defendant/Appellant Jeffries is represented by retained counsel on appeal.
8. Defendant/Appellant Jeffries has not been granted leave to proceed in forma pauperis.
9. Proceedings commenced in the district court in this matter with the filing of an Information on February 14, 2012.
10. This is a criminal case in which Defendant/Appellant Jeffries was charged by Information with the offense of Murder With Use of A Deadly Weapon (Open Murder) (Category A Felony pursuant to NRS 200.010, 200.030, 193.165), which was alleged therein to have been committed on or about October 23, 2011, at and within Clark County, Nevada. Defendant/Appellant Jeffries entered a plea of not guilty with respect to the charge set forth in the Information. Following a jury trial conducted from March 23, 2015 through March 26, 2015, a verdict was returned finding Defendant/Appellant Jeffries guilty of Second Degree Murder With Use of A Deadly Weapon (Category A Felony). On May 27, 2015 Defendant/Appellant Jeffries was adjudged guilty of Second Degree Murder With Use of A Deadly Weapon and sentenced to life imprisonment with parole eligibility after a minimum of ten (10) years of imprisonment

1 have been served, plus a consecutive term of seventy-two (72) months imprisonment  
2 with parole eligibility after twelve (12) months of imprisonment have been served for  
3 the Use Of A Deadly Weapon; with four hundred (424) days credit for time served, the  
4 total aggregate sentence of imprisonment being life with a minimum of one hundred  
5 thirty-two (132) months; restitution in the amount of Four Thousand Six Hundred Fifty-  
6 One Dollars and Eighty-One Cents (\$4,651.81); a One Hundred Fifty Dollar (\$150.00)  
7 DNA Analysis Fee, a Three (\$3.00) DNA Collection Fee; and Twenty-Five (\$25.00)  
8 Administrative Assessment Fee. The Judgment of Conviction in this matter was filed  
9 by the district court on June 2, 2015. Defendant/Appellant Jeffries has appealed from  
10 the Judgment of Conviction and all rulings, decisions and orders of the district court  
11 ancillary thereto; and from the sentence imposed by the district court with respect  
12 thereto.






