MEMORANDUM

This is appeal from a judgment of conviction for 2nd Murder With Deadly Weapon by jury verdict. Appellant was sentenced to life with parole eligibility after ten years, plus a consecutive 12 to 72 months for the deadly weapon enhancement, and was given 424 days credit for time served. The Judgment of Conviction was filed on June 2, 2015, and the Notice of Appeal on June 29, 2015. Although briefing of the appeal is nearly complete, Appellant has now moved for release pending appeal which the State opposes.

A motion for bail or release pending appeal ordinarily must be submitted, in the first instance, to the district court. Polito v. State, 70 Nev. 525, 526, 275 P.2d 884, 884 (1954), superseded by statute on other grounds as stated in In re Austin, 86 Nev. 798, 477 P.2d 873 (1970); NRS 177.145; NRAP 8(e). This is because, in considering a motion for bail pending appeal, this Court does not conduct its own fact-finding proceeding, but makes an independent judgment based upon a review of the reasons for denying bail which were relied upon by the district court. Lane v. State, 98 Nev. 458, 652 P.2d 1174 (1982); In re Austin, 86 Nev. at 802, 477 P.2d 876. Ultimately, a defendant "who has been convicted of a violent, serious offense and who faces a substantial term of imprisonment will shoulder a heavy burden" to demonstrate factors weigh in favor of allowing bail pending appeal. Bergna v. State, 120 Nev. 869, 877, 102 P.3d 549, 554 (2004).

It does not appear from the record below that Appellant has submitted the

question of release pending appeal to the district court in the first instance, nor does

Appellant claim to have done so. The statement of facts in Appellant's motion does

not contain a single citation to the record nor attach any exhibits in support of the

factors for consideration of bail. To the extent Appellant premises his argument for

release upon allegations made in his motion for sanctions, the State likewise

incorporates by this reference its opposition to the sanctions motion. Appellant fails

to cite any authority for the proposition that this Court may release a convicted

murderer on bail pending appeal purely as a sanction against the State and without

regard to the merits of the issue. Because this Court does not act as a fact-finder, the

record is incomplete and inadequate for consideration of Appellant's release pending

appeal.

WHEREFORE, the State respectfully requests that release pending appeal be

denied.
