

AND SONNIA ILIESCU 1992 FAMILY TRUST AGREEMENT (jointly hereinafter "Appellants"), and, pursuant to this Court's Order reinstating briefing, dated January 13, 2016, requiring that Appellants file and serve any Transcript Request Form pursuant to NRAP 9(a), hereby notify the Court that they are not requesting the preparation of transcripts for this appeal.

No Transcript Request Form is needed in this case inasmuch as the complete trial transcript was previously prepared and has been filed in the district court by the court reporter, in filings on February 24, 2014 (Washoe County District Court Clerk Transaction Nos. 4317125; 4317129; 4317492; and 4317495), and in a repaginated filing of day one of the trial transcript filed by the court reporter on February 27, 2015 (Transcript Transaction No. 4837383). Pursuant

to Rule 9(a)(1)(B), the Appellants only need to file a transcript request form “when a verbatim record was made of the district court’s proceedings and the necessary portions of the transcript were not prepared and filed in the district court before the appeal was docketed.” Other potentially relevant hearing transcripts are also already prepared and on file. Thus, preparation of the transcripts to be included within any transmission of the trial court record ordered under NRAP 11, and to be included by Appellants as part of the appendix under NRAP 30(b)(1), does not need to be specially requested at this time.


