FACTS

This case involves the dismissal with prejudice of a case pursuant to NRCP 41(e). The standard of review is for abuse of discretion.

The appellant Saticoy Bay LLC Series 2021 Gray Eagle Way obtained title to the real property located at 2021 Gray Eagle Way, Las Vegas, Nevada on July 18, 2013 at an HOA foreclosure sale conducted pursuant to NRS Chapter 116.

There was already a lawsuit pending between the former owner and the HOA. The appellant moved to intervene in the case, and the motion was granted.

On June 22, 2015, the case was dismissed pursuant to NRCP 41(e) with

prejudice.

If this court should uphold the dismissal with prejudice, both the appellant and the respondent would be damaged because there would be no determination regarding the extinguishment of the deed of trust, potentially leaving the property encumbered by the extinguished deed of trust for perpetuity.
