## **I**

### **INTRODUCTION**

Petitioners, Rhonda Helene Mona (“Rhonda”) and Michael J. Mona, Jr. (“Mike”) (collectively “the Monas”), hereby submit this Limited Opposition to Real Party in Interest Far West Industries’ Motion to Exceed Page Limit Pursuant to NRAP 32(a)(7)(D) (“Motion to Exceed Page Limit”) on Far West’s Opposition to Petitioners’ Emergency Motion for Relief Under NRAP 27(e) and Supplement to Emergency Motion for Relief Under NRAP 27(e) (“Opposition”).

## **II**

### **MEMORANDUM OF POINTS AND AUTHORITIES**

An opposition to a motion filed in the Nevada Supreme Court is limited to ten pages, unless permission is provided by the Court. NRAP 27(d)(2). In its Motion to Exceed Page Limit, Far West requests permission to submit its twenty-page Opposition. Far West requests this extension to sufficiently address the facts and arguments in the Emergency Motion for Relief Under NRAP 27(e) and the Supplement to Emergency Motion for Relief Under NRAP 27(e). Far West’s proposed twenty-page Opposition includes analysis of a four-part test for injunctive relief and a five-factor test regarding alternative security to the supersedeas bond requirement.

The Monas have no objection to the page limit extension, provided they are provided additional pages to sufficiently respond in their Reply to the more lengthy analysis proposed by Far West. Should the Court find good cause to

grant leave for Far West to exceed the page limit for its Opposition, the Monas request an extension in length of the Reply to ten pages.

### III

### CONCLUSION

The Monas do not oppose Far West's Motion to Exceed Page Limit, provided the Monas may also submit up to 10 pages to sufficiently respond to in their Reply.
