1	Minutes 05/06/2015 3:00 AM - This Court having considered the Defendant s Supplemental Writ of Habeas Corpus, all related pleadings, arguments, and the Court record first FINDS that the instant Writ is not a Supplemental Writ to the first Writ of Habeas Corpus filed years ago, but instead a Second Writ of Habeas Corpus. Further, this Court FINDS that this Second writ is time-barred, and Defendant puts forth not good cause for the delay. As previously established in the record in this case, Defendant was on notice of the denial of his appeal in July of 2010, before the time of the deadline for the first Writ which was filed a year late. Four years later, Defendant has failed to overcome the procedural bar. Additionally, Mr. Brower s appointment four months after the time period for filing and his conduct as post- conviction counsel does not make this Petition Supplemental, nor timely. This Court agrees with the State s position in its Response and Motion to Dismiss and as a result ORDERS the State s Motion to Dismiss GRANTED for the reasons stated herein. Court ORDERS the District Attorney to prepare the Findings of Fact and Conclusions of Law and Order which tracks the language of the State s Response and Motion to Dismiss, and this minute order.
