Because your whole detective squad 13 actually arrived at scene do you split up the duties for your investigation? 15 16 Α Yes. 17 Is it fair to say that some people conduct witness 18 interviews? 19 The majority of the detectives conduct the 20 witness interviews as well as the canvas of the neighborhood. 21 Q Okay. And then my partner or I would take the 22 23 responsibility of documenting the crime scene along with crime 24 scene analysts.

24	Q	Do you recall now who that vehicle was registered
25	to?	

1 Α It was a Ford Escort, and it returned a Nevada DMV to Joseph Averman. Okay. Was there anything else of evidentiary value 3 that you noticed in that driveway or that was pointed out to 5 you as having evidentiary value? Α Yes. 6 What was that? 8 There was a backpack that was left in the driveway here. And inside of the backpack there was an empty gun 10 holster. 11 Showing you State's Exhibit 24. Is that the empty 12 gun holster you've just described? 13 Α Yes. 14 And there was also just some loose change inside 15 that backpack; correct? 16 Correct. 17 And that's essentially the extent of the contents of 18 that backpack? 19 Α Yes. 20 And why was that holster important to your Q 21 investigation? 22 Because at this point we believe we were looking for 23 an outstanding firearm. 24 Did you actually find a firearm at the scene? 25 Α No.

1 Q Did you go inside that house at 325 Altamira? 2 Yes. 3 And the two victims that you learned had been shot 4 were already -- had been removed and attended to by 5 paramedics? 6 Α Correct. 7 And they'd already left the scene? 0 8 Correct. 9 All right. So when you went in what was your goal? 10 To gather as much evidence as we could to help Α determine what took place inside the house prior to our 11 12 arrival. 13 Okay. And you were accompanied by a crime scene 14 analyst by the name of Tracy Branley now known as Tracy Kruse? 15 Correct. 16 Okay. Did you observe the living room area as 17 depicted in Exhibit 39? 18 Α Yes. 19 Was there anything of evidentiary value there that 20 you found that was important to your investigation? 21 Α I believe that living room area was kind of unremarkable as far as the case went. 22 And Defendant's Exhibit E, the kitchen area leading 23 24 into the living room area, same thing, unremarkable? 25 Α Correct.

Q All right. These photographs on the wall as 1 depicted in Defendant's Exhibit A and B, unremarkable; 3 correct? Correct. Α 5 Not important to your investigation? 0 Other than to establish the relationships. Okay. At some point you went into a room that I believe you and the other detectives began identifying as the craft room? 10 Α Correct. 11 And this was located down the end of the hallway on 12 the right-hand side? 13 Α Yes. 14 And you went in there with CSA Branley or CSA Kruse? 15 Correct. Α And what, if anything, did you notice on the ground 16 there that was important to your investigation? 17 In the craft room I believe we located articles of 18 Α 19 clothing, which should have been removed during life saving 20 efforts by paramedics. There was also a cellular telephone I 21 believe -- actually, I believe there were multiple cellular 22 telephones recovered from that room. 23 Okay. Showing you State's Exhibit 47. Does this 24 appear to be a shot of that craft room from the hallway?

1 And those are depicted in there with the evidence 2 marker 7 through 11. Those are the clothing that were removed by paramedics before you arrived? Correct. 5 State's Exhibit Number 52. Why was that important 6 to your investigation? Α This here was the shirt that appeared to be removed from Ms. White or Lucas, and it's important to the 9 investigation because of the defects or holes that would be in 10 it. And you can -- was this apparent to you that it had 11 been removed from her body by being cut off? 12 13 Yes. And you can see up here that the bands on the 14 15 shoulders, where it has been cut? 16 Yes. 17 Okay. You also mentioned that there was a number of cell phones. Do you remember how many cell phones were 18 19 recovered throughout the house? 20 Throughout the house or just the craft room? Α Just the craft room. Let's start there. 21 I believe in the craft room there were two. 22 So there were several cell phones that were 23 24 recovered throughout the house though? I also remember seeing additional cell phones in the 25

room directly across the hall, as well. 2 0 State's Exhibit 54 though, what is depicted in that? 3 Α That's a cell phone, a white Apple iPhone that was recovered from the craft room. 5 Now, did that to you end up being the only cell phone of evidentiary value in the course of your 7 investigation? 8 Α Primarily, yes. 9 Q Did you determine whose cell phone that was? 10 This phone belonged to the victim, Echo. 11 Echo Lucas? 1.2 Α Lucas, yes. 13 Q Also known as Echo White? Correct. 14 15 All right. Did you cease that cell phone and 16 impound it as evidence? 17 Yes. And subsequent to your examination of the house and 18 19 whatever else you did that day, which we'll get into, did you 20 ask for that phone to be forensically examined by a division 21 of the Las Vegas Metropolitan Police Department? 22 Yes, I did. Α And the purpose of that was to determine the 23 24 contents of that phone? 25 Α Correct.

Text messages, photos, things of that nature? 1 2 Correct. Across the hall from the craft room is the master 3 4 bedroom; correct? 5 Yes. Α And you took a look inside that master bedroom during the course of your investigation? 8 Yes. Α Showing you State's Exhibit 55. What do we see 10 here? That's looking from the hallway almost directly 11 south right into the master bedroom. You see the baby crib 12 there, and a broken mirror beyond that. You can't really tell 13 in this picture, but there's a bullet hole in the wall that 14 15 exited out the south side of the house out toward the driveway 16 area. Also, while you were in there did you observe the 17 area directly in front of the dresser depicted in 58? 18 19 Α Yes. And do you see the blood there depicted in front of 20 that dresser? 21 22 Α Yes. And was that identified to you as the location where 23 Joseph Averman, the other victim, had been laying? 24 25 Α Yes.

1 At the time that you made entry did you see what's 2 depicted in State's Exhibit 59? 3 Α Yes. And was does that appear to you to be? I believe it was a shirt that was removed from Mr. 5 Averman by paramedics prior to our arrival. 6 And was that ceased as evidence? 8 Α Yes. And after it was ceased as evidence was it 9 10 photographed? Α Yes. 11 Showing you State's Exhibit 60. Is this a 12 photograph that was taken by crime scene analysts depicting 13 that shirt I guess as it should look? 14 15 Yes. And it's covered in blood, is it not? 16 17 Yes, it is. As the other detectives in your squad were 18 conducting interviews of the witnesses that we briefly 19 20 mentioned did they update you with the information that they 21 were learning? 2.2 Α Yes. And did you, based upon the information that you 23 were told, develop the name of a suspect in this case? 24. 25 Yes, we did.

And what name was that? 1 2 Α Troy White. And did you learn the relationship between Troy 3 White and Echo Lucas? 4 Troy White was the estranged husband of the victim. 5 Did you learn whether Troy White was living there on б 7 a full-time basis at 325 Altamira? I learned that he was not living there on a full-8 time basis. He would stay there on the weekends only. 9 And so you knew at this point that Troy White 10 Q presumably had a firearm that he used to shoot Echo White and 11 12 Joseph Averman; correct? Yes. 13 Did you subsequently conduct an investigation to 14 determine whether Troy White had what's known as a carrying a 15 concealed weapon permit? 16 17 Yes. And what is a carrying a concealed weapon permit? 18 It's a permit that's issued by the sheriff here in 19 Clark County to authorize someone to carry a weapon concealed 20 on their person not readily identifiable where someone else 21 may see the weapon. It's a permit to keep a gun hidden on you 22 23 basically. So you, for example, as a detective you 24 All right.

might carry a handgun hidden?

1 Α Correct. 2 And do you have a CCW? 0 3 I do not. Α Because you're a law enforcement agent? Q 5 Correct. Α 6 All right. But for us regular folks, we have to 7 have a CCW permit? 8 Α Correct. 9 All right. And that's so I can put a gun inside my Q 10 coat pocket or stuff down the back of my pants and hidden by 11 my shirt? 12 Anywhere where it's not readily identifiable. 13 Q Did Troy White have such a permit? 14 Α No, he did not. 15 And there are -- a list of the permit holder is kept 16 by the Las Vegas Metropolitan Police Department? 17 Α Yes. 18 He was not on that list? 19 Α Correct. 2.0 After you learned the identity of the possible 21 shooter did you convey that information to other members of 22 the Las Vegas Metropolitan Police Department? 23 We did. We sent out an ATL with Troy White's 24 information and also an update on the possible vehicle that we 25 believed he was driving at the time.

1 Q So an ATL. Is that what you said? 2 Correct. 3 What does that mean? Sorry. It's an attempt to locate. 5 Does that mean that you notified other -- all the б other police officers in the county to be on the lookout for a particular person? Correct. 8 Α 9 Troy White? 10 Α Yes. And did you also learn the make and model and 11 Q 12 license plate number of a car that he may be driving? 13 Α Yes. 14 And that was a 2008 Dodge Durango? 15 Correct. All right. Later that day and during the course of 16 17 your investigation did you receive some sort of information that Troy White had turned himself in? 18 19 Α Yes, we did. 20 About what time was that? I believe it approximately 5:45-ish that afternoon. 21 we were still at the scene, so just before dark I believe. 22 23 So you had been on that scene for about four, four 24 and a half hours by the time that you learned that Troy White

1 Α Correct. 2 0 And where did you learn that he had turned himself 3 in? Α The call came through our dispatch from Prescott, Arizona, that was the location where he had turned himself in at. Did you at some point drive down to Prescott, Arizona? Α Correct. A little bit after receiving the information that he was there, then my partner and I along 10 11 with a crime scene analyst responded to that location. 12 Q How long did it take you to get there? It's somewhere around the four hour range I would 13 14 guess. 15 And during the course of your investigation did you 16 learn that Troy White and Echo White had been members of a 17. religious sect called The Potter's House? 1.8 Yes. 19 And does Prescott, Arizona have any significance for 20 that religious group? 21 It ended -- yes, it did have significance. believe it was -- The Potter's House Church was founded there 22 23 by, and I can't remember the gentleman's name, but that was

the founding location of that church. And I believe it

occurred in the '70s, maybe 1970.

24

Q And did you also subsequently delve into the religious beliefs of The Potter's House?

A Yes, because I wanted to learn if there was any importance to turning yourself in in Prescott, Arizona versus Las Vegas. So that's kind of how that came about. And then I looked a little bit into The Potter's House organization itself.

Q And what did you learn about the various roles in a relationship between a man and a wife according to that particular religious group?

A It seemed pretty strict organization where the woman would remain subservient to the man, stay at home, raise the kids type situation where the man would provide, go to work and provide. And obviously they were not to live in a life of sin such as drinking, smoking, tattoos were looked down upon.

Q And during the course of your investigation did you learn that actually Troy White and Echo White abided by those two different roles, meaning Echo White stayed at home with the children while Troy White was the provider and worked?

A Yes.

Q Getting back to Prescott, Arizona though. You mentioned that you went down, with CSA Branley was it, to Prescott, Arizona?

A At the time Branley, yes. Tracy Branley.

Q And what was the purpose of going down there?

A Well, a couple of things we wanted to do. Obviously we were still looking for evidence in our case. We were still missing a firearm. We would obviously like the chance to talk to Mr. White about what happened. And basically continue to gather evidence at that location to help try and determine what had happened here in Las Vegas.

- Q Did you conduct a search with CSA Branley or CSA Kruse of the 2008 Dodge Durango that officers in Prescott, Arizona had taken into custody?

I knew the State might not like the photographs. That's why I asked to approach rather than putting them up.

MR. COFFEE: Very good. Thank you.

What Mr. Coffee I think is trying to say is that these photographs effected the defendant's state of mind. He's seeing his wife in these photographs. All of these photographs are with Echo Lucas—White with her boyfriend, but they're on her phone. If they're to affect the state of mind of the defendant they had to have been seen by the defendant.

THE COURT: Well, they can -- wait. They can be text messages to him, they can be posted on Facebook pages, there's lots of ways they can be transmitted. And I haven't heard the information from the detective that tells me any of that stuff.

MR. ROGAN: All right.

THE COURT: Even the victim could show them on the iPhone, too.

MR. ROGAN: Correct. And that's my point. I think that that has to be shown in order for these photos to be admitted. More than --

Is it fair to say that when -- people don't put 15 pictures of themselves when they're arguing with their spouse? 16 Correct. 17 Α They don't take pictures of that, they don't take 18 0 selfies with a selfie stick when they're arguing; right? - A Correct. It's actually very, very difficult in a dynamic scene, a dynamic crime scene where people are moving and multiple shots are being fired. It's really tough to make the relation sometimes between certain holes and as they pass through the body. So very difficult sometimes.
- Q All right. And given that you are trying to apprehend the person who committed the offenses that occurred at 325 Altamira, are you at all really concerned with whether a bullet has any tissue or material on it?
- A Only if I can see visibly that it had. If there were blood visible on the wall where it passed through or even tissue or blood visible on the bullet itself, then that's

something that we would have to pay attention to. However, when you look at it and you don't see any tissue or blood on it, then you don't become overly concerned with testing it for bullet -- or blood or anything like that.

Q Was it important to you at all to test that bullet for blood?

A No.

Q Would it have helped your investigation at all to determine whether Mr. White murdered his wife and attempted to kill Joseph Averman?

Q Can you tell us a little bit about your educational background and the training that you had to undergo in order to become a fingerprint examiner.

I have a bachelor's degree with a double major Yes. in biology and chemistry. Prior to hiring on as a forensic scientist, like I said, I was a crime scene analyst. So in that capacity I got quite a bit of experience with photography and processing and comparison, I mean, processing and developing of latent prints, evidence packaging and recovery and things like that. And then after about three and a half years in March of 2007 I tested and promoted into the lab as a forensic scientist trainee in the latent print unit. Went through an 18 month rigorous training program to qualify me to do independent casework as a forensic scientist to do latent print comparisons. Not so much the field work anymore, but now actually processing and recovering latent prints, comparing latent prints, analyzing them to see if they're of value for comparison, comparing them to known people and then running any unidentified prints into our AFIS databases.

So after that, in December of 2009, I was eligible to test to become a certified latent print examiner, passed that test, so I'm certified with the International Association for Identification. I have taught different course work and latent prints to our own department as well as in Utah and

Phoenix, in Arizona. 1 In January of 2013, I became published. And my 2 first article, I did an article called Palm Prints, that's in 3 the Encyclopedia of Forensic Science, and I'm proficiency tested annually. So --Okay. And do you also undergo yearly continuing 6 education? 7 We do. We have things that we have to maintain, 8 which most of it is our proficiency tests that are done every year. 10 And have you testified in the Eighth Judicial Court 11 regarding fingerprint examinations before? 12 Yes, I have. 13 How many times have you done that? 14 I think this is my 10th. Α 15 Have you testified at any preliminary hearings or 16 Grand Jury proceedings within the County of Clark? 17 Yes, I have. Α 18 How many times have you done that? 19 It's eight or nine for Justice Court and I think 20 five or six for Grand Jury, I forget the number --21 Okay. Ms. Carter, I want to direct your attention 22 to some examinations that you completed in this specific case. 23 24 Α Okay. The forensic request is a request to have someone 25 Q

like you examine evidence as initiated; correct? Yes. 2 .And that's done by a detective that's assigned to 3 the case typically? Α 18 And you were asked to look at a magazine and twelve 19 9 millimeter cartridges, a magazine and nine 9 millimeter 20 cartridges, and one 9 millimeter cartridge that was packaged 21 by itself; correct? 22 That's correct. Α 23 Can you explain for the jurors what a latent 24 fingerprint is. 25

palms also, and the soles of our feet and our toes, we have specialized skin called friction ridge skin. Basically it's raised ridges. Those ridges have patterns and they have features that are unique to each individual. It's similar to a rubber stamp. If I -- or it would take some sort of matrix of oil or sweat and touch a surface, I'll leave an impression of those ridges on that surface. That impression that's left there is called a latent print. Latent by definition means there, present, but not readily visible. So we can enhance it with lighting, different lighting techniques, or powders to stick to those residues, or some chemicals that allow us to see those. So ideally what we're trying to do is visualize that latent print so I can compare it.

- Q And are there certain factors that influence whether or not a latent print is actually left behind?
 - A Yes.

- O What are those factors?
- A We have factors, basically five that we talk about. One is the skin itself. So if the skin is damaged in some sort of way or if it's covered with a glove or something, obviously the skin's not going to leave a latent print. Then that matrix, that residue that I was talking about, if the -- again, similar to a rubber stamp, if the ink's dry I can press that stamp on that ink pad all day long and I'm not going to

leave an impression. So if I don't have some sort of residue on my skin I'm not going to leave an impression there, so the residue matters.

The surface itself matters. If the surface is really porous, if it's very -- if it's highly textured, things like that can affect it. If it's nice and smooth and clean, generally it's a better surface for latent prints. How it's touched matters. If I take a nice -- even an ideal surface and I press too hard I can obliterate that ridge detail, when I can just, you know, make it where it's not valuable for an examiner to compare. If I move it around and slide it and do things like that, so how it's touched matters.

And then also time, how much time and the conditions that occur after the latent print is left. So if it's left out in the sun for, you know, three years on the outside of a car, might not have great chances of developing that latent, you know, afterwards. If it was just yesterday inside an environment, might be a little bit better. If it was wiped or left out in the humidity in the rain, so those environmental factors play into -- come into play also.

- Q Okay. You mentioned that the surface of an object will affect whether or not a latent print is left behind?
 - A It can, yes.

Q With regards to firearms, are you typically successful in developing usable latent prints?

A No.

Q When I say usable, what do I mean?

A Of value for comparison is what you mean I think. I'm assuming that's what you mean.

Q Why is it that firearms don't typically yield good results for you?

A There's some factors. Again, this would be just my opinion, every firearm's different. I mean, you know, a firearms manufacturer doesn't want to make a gun that's going to rust right away. So they spray them with different chemicals, there's some polymers on some of the guns, these plastic things that -- plastic coatings that don't really allow things to adhere to them. Often times those areas that are handled in a conventional way to handle a gun are textured. They're textured so we don't drop it easily, so those textured surfaces, again, affect whether a latent print is left. Also, if -- sometimes there's military coatings, there's bluings, there's all kinds of different things that

just inhabit -- or inhibit the residue from sticking which 1 would allow us to develop the latent print. How successful are you typically with recovering 3 latent prints from a live cartridge, an unfired round? 4 Very poor, successfully. Not very successful at 5 all. We actually did a study at our lab, too, and the results 6 -- we did a two-year study with -- we looked at the -- of our -- of about 3,000 cartridges, live cartridges that were analyzed, and it was 0.16 percent of those we developed a 9 latent on, so it was so low. We actually have a policy now 10 that we do not process cartridges. 11 A sample limits policy? 12 Correct. Yes. Α 1.3 What about fired rounds? 14 Fired rounds is also very low. 15 Α And are fired rounds also subject to that sample 16 limit policy? 17 It is, yes. A 18 Meaning you won't test fired rounds either? 19 0 Correct. Α 20 Is the same true for DNA? 21 Yes, as far as I know they do not process those. 22 Α Is that because during the firing process things 23 0 like oils and DNA are destroyed? 24 I would assume for DNA.
