3 Note that the disc subject to the instant motion, Defendant's proposed OO and PP, each
4 contain a single digital audio file using the "Adaptive Multi-Rate" (.AMR) file type .

5
6 The "Adaptive Multi-Rate" (.AMR) file type is used natively by Apple iPhones for
7 voice-mail storage.

8 The "Adaptive Multi-Rate" (.AMR) file type is not playable with standard versions of
9 Windows Media Player nor is it playable via more recent versions of Apple iTunes.

10 Free and reliable playback methods are readily available for "Adaptive Multi-Rate"
11 (.AMR) files, the most common being the Apple's "Quicktime" or "Quicktime for Windows."

12 "Quicktime" is included as software on most Apple computing products including the iPad.
