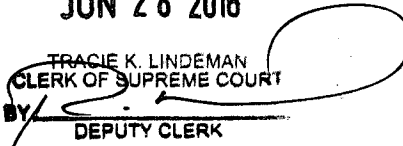

making the deadline for Appellant to file his Reply Brief no later than sixty (60)

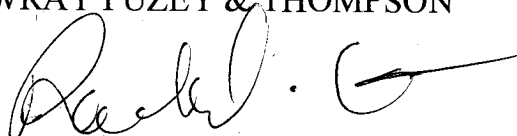

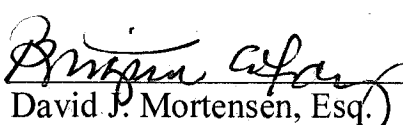

ORDER

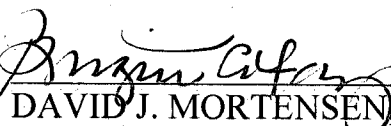
