A708447, with each party to bear their own attorneys' fees and costs;

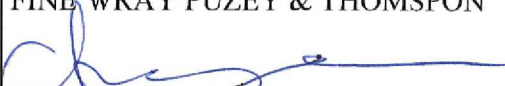
