On February 17, 2017, the briefing in the instant matter was completed. While preparing for impending oral arguments it has come to the undersigned counsels' attention that the case Andrew v. Coster, et al., bearing Case No. 70836 raises the same or similar issues as the instant matter. Moreover, in both the Respondents' Answering Brief and Appellants' Reply Brief in Andrew v. Coster. et al., Case No. 70836, it was agreed in the respective Routing Statements that "clustering of these cases is warranted under this Court's Internal Operating Procedures Rule 2(c)(2) in order to ensure that they are resolved in a consistent manner and to avoid the possibility of inconsistent published decisions . . ." Appellants' Reply Br., Richey L. Andrew vs. Sharon Coster, et al. at 2. Here, Respondents Dr. Barnum and Dr. Zipf agree with this position. Both Peck and Andrew involve the same constitutional challenge to NRS 41A.071. Despite that these cases raise the same or similar issues, Peck v. Zipf, et al. is set for oral argument on September 26, 2017 in the Supreme Court of the State of Nevada (see Order Re: Scheduling of Oral Argument) and Andrew v. Coster, et al. was transferred to the Nevada Court of Appeals (see Order Transferring Case) and set for oral argument on September 19, 2017. This scheduling and transfer has created the exact scenario that Internal Operating Procedure Rule 2(c)(2) sought to avoid; the possibility of inconsistent published decisions. Accordingly, Respondents Dr. Barnum and Dr. Zipf respectfully request that this Honorable Court recall Andrew v. Coster, et al., Case No. 70836, retaining jurisdiction under NEV.R. APP. P.
