ORDER DENYING STAY

Docket No. 68523 is an original petition for a writ of mandamus and/or prohibition challenging a district court order interpreting the Minimum Wage Amendment to the Nevada Constitution, Art. XV, § 16. Petitioners have moved for a stay of the district court proceedings pending this court's consideration of the writ petition. The motion is opposed. Having considered the motion for stay, the opposition, and the reply, we conclude that a stay is not warranted at this time. NRAP 8(c); *Fritz Hansen v. Eighth Judicial Dist. Court*, 116 Nev. 650, 657, 6 P.3d 982, 986 (2000). Accordingly, we deny the motion for stay without prejudice to the parties' right to refile the motion if circumstances so warrant.

It is so ORDERED.
