Order to Show Cause why the appeal should not be dismissed. In response, 1 undersigned counsel indicated, as suggested by this court, that entry of default 2 3 judgment would be forthcoming. Since then, a "prove-up" hearing was held and 4 default judgment was entered against Brian and Jennifer Ferguson.¹ An order was 5 6 drafted² and subsequently sent to Department III in the Eighth Judicial District 7 Court.³ At this time, undersigned counsel is waiting for the order to return from 8 9 court. 
