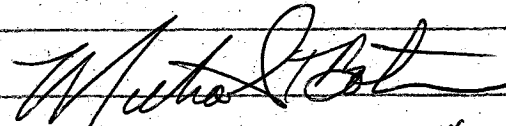
APPELLANT HAS COME TO THE SOBER CONCLUSION THAT THIS COURT

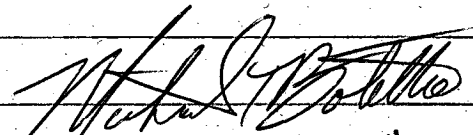
