- NRS 485.035 defines Judgment in pertinent part as any judgment upon a cause of action arising out of the ownership, maintenance or use of any motor vehicle for damages, including damages for care and loss of services because of injury to or destruction of property, including the loss of use thereof, or upon a cause of action on an agreement of settlement for such damages. The Administrative Law Judge, Thomas Sutherland, held that the Department's action in suspending Petitioner's driving and registration privileges is dismissed and rescinded. Such action is not appropriate because the portion of the ORDER OF JUDGMENT fees and costs awarded to Simmons are not damages based upon a cause of action arising from the ownership or operation of a motor vehicle. After a fair reading of NRS Chapter 485, Motor Vehicles: Insurance and Financial Responsibility, it seems the purpose is to require liability insurance to compensate people who are injured or whose property has been damaged by someone negligently operating a motor vehicle. NRS Chapter 485 does not seem to be designed for insurance companies to suspend a person's license for a civil judgment related to attorney's fees because the Plaintiff did not exceed the arbitration award at trial. Therefore, COURT ORDERED, Petitioner's Petition for Judicial Review is DENIED.

Respondent made a Motion for Sanctions pursuant to NRCP 11. Petitioner did not file this Petition for Judicial review in bad faith. Thus, COURT ORDERED, Sanctions are inappropriate and are
