Appellant was convicted of: Count One: Murder, Count 2 - Degrees of Murder, Count 3 - Use of a Deadly Weapon or Tear Gas in Commission of Crime. A Judgment of Conviction was entered on March 13, 2012. He then filed a Petition for Writ of Habeas Corpus (Post-Conviction) and an Evidentiary Hearing was held on September 10, 2015. The Findings of Fact Conclusions of Law and Order was filed on October 26, 2015. The court denied the petition. This appeal follows.
