DECLARATION OF JONELL THOMAS

JONELL THOMAS, hereby declares as follows:

I am an attorney duly licensed to practice law in the State of Nevada, and the Chief Deputy Special Public Defender assigned to handle Mr. Collins direct appeal from his jury trial. The case was docketed on December 2, 2015 and the Opening Brief and Appendix are due March 31, 2016.

Most of the transcripts were not received until February, 2016 and preparation of the appendix could not begin until the transcripts were filed.

We attempted to send the appendix to the client at High Desert State Prison, but they were not delivered and were instead sent back to the counsel after approximately four weeks. It is counsel's understanding that this is not an isolated incident but is a reoccurring issue with the mail room at the Prison.
