MOTION TO CONSOLIDATE APPEALS

Pursuant to NRAP 3(b)(2), appellants hereby move to consolidate appeal No. 70864 with No. 69333 and No. 69889, which are already consolidated.

These three appeals all arise out of the same district court case and involve the same parties. No. 69333 is the appeal from the judgment; No. 69889 is an appeal from post-judgment orders dealing with attorneys' fees and costs; and No. 70864 is an appeal from a different order awarding attorneys' fees after the first one.

On July 12, 2016, this court entered an order consolidating No. 69333 and No. 69889, in the interest of judicial economy. No. 70864 was docketed shortly thereafter. Because No. 70864 also arises from the same district court case and involves the same parties, appellants contend that the interest of judicial economy would be served by consolidating No. 70864 with the other two appeal dockets, so that all three dockets can be briefed and argued together.¹
