This Court should exercise its inherent authority and strike the rogue filing entitled "Notice of Clarification Regarding Oral Argument." Nationstar and FHFA submitted this rogue document purportedly "because of time constraints" imposed by this Court during the March 7th oral argument. Notice, 2:¶2. The rogue "Notice" is entirely improper, a belated attempt to discuss "whether a contractual relationship exists between Nationstar and FHFA as Conservator for Freddie Mac." Notice, 2:¶2. Nationstar and FHFA had more than enough time to discuss this issue during the March 7th oral argument. Indeed, Nationstar and FHFA had 29 minutes to do so, which is six more minutes than SFR had; how Nationstar and FHFA decided to use their 29 minutes was entirely up to them. During oral argument, this Court—on more than one occasion-graciously gave Nationstar and FHFA additional time for oral argument. The Notice takes advantage of this Court's generosity, and demands relief (i.e. the opportunity to "clarify" an issue) without having the procedural decency to file a motion. In short, Nationstar and FHFA's rogue Notice violates NRAP 27(a)(1) because it impermissibly demands "relief" without filing a motion. NRAP 27(a)(1); *In re Dunleavy*, 104 Nev. 784, 787, 769 P.2d 1271, 1273 (1989).

¹ Chambers v. NASCO, Inc., 501 U.S. 32, 43 (1991) (discussing courts' inherent authority); Kapetan v. Cox, No. 3:13-cv-00171-MMD-VPC, 2014 WL 5469335, at *12 (D. Nev. Oct. 28, 2014) (reviewing inherent authority to strike filings).

This Court should strike the Notice or, in the alternative, consider SFR's Response, which is attached hereto as **Exhibit A**.
